AN ACT

1 RELATING TO THE APPROPRIATION TO THE DEPARTMENT OF HEALTH AND WELFARE FOR
2 FISCAL YEAR 2022; APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF
3 HEALTH AND WELFARE FOR THE DIVISION OF MEDICAID IN THE ENHANCED MEDIC-
4 AID PLAN FOR FISCAL YEAR 2022; REDUCING THE APPROPRIATION TO THE DEPART-
5 MENT OF HEALTH AND WELFARE FOR THE DIVISION OF MEDICAID IN THE ENHANCED
6 MEDICAID PLAN FOR FISCAL YEAR 2022; APPROPRIATING ADDITIONAL MONEYS TO
7 THE DEPARTMENT OF HEALTH AND WELFARE FOR THE DIVISION OF MEDICAID FOR
8 THE EXPANSION MEDICAID PLAN FOR FISCAL YEAR 2022; AND DECLARING AN EMER-
9 GENCY.

11 Be It Enacted by the Legislature of the State of Idaho:

12 SECTION 1. In addition to the appropriation made in Section 1, Chap-
13 ter 303, Laws of 2021, and any other appropriation provided by law, there is
14 hereby appropriated to the Division of Medicaid for the Enhanced Medicaid
15 Plan \$121,255,800 from the Cooperative Welfare (Federal) Fund to be expended
16 for trustee and benefit payments for the period July 1, 2021, through June
17 30, 2022.

18 SECTION 2. Notwithstanding any other provision of law to the contrary,
19 the appropriation made to the Division of Medicaid for the Enhanced Medic-
20 aid Plan in Section 1, Chapter 303, Laws of 2021, from the Cooperative Wel-
21 fare (General) Fund is hereby reduced by \$132,390,300 for trustee and bene-
22 fit payments for the period July 1, 2021, through June 30, 2022.

23 SECTION 3. In addition to the appropriation made in Section 1, Chap-
24 ter 303, Laws of 2021, and any other appropriation provided by law, there is
25 hereby appropriated to the Division of Medicaid for the Expansion Medicaid
26 Plan the following amounts to be expended for trustee and benefit payments
27 from the listed funds for the period July 1, 2021, through June 30, 2022:

32 SECTION 4. An emergency existing therefor, which emergency is hereby
33 declared to exist, this act shall be in full force and effect on and after its
34 passage and approval.
