STATEMENT OF PURPOSE

RS29765 / S1400

This is the FY 2023 original appropriation bill for the Office of Information Technology Services. It appropriates a total of \$16,974,900 and caps the number of authorized full-time equivalent positions at 135.00. For benefit costs, the bill increases the appropriated amount for health insurance by \$850 to \$12,500 per eligible full time FTP, includes a one-year holiday of unemployment insurance, and adjusts workers compensation amounts. The bill also provides funding for permanent employees for the equivalent of a 3% salary structure shift and provides \$1.25 per hour per eligible employee to be distributed based on merit for change in employee compensation. The bill funds four line items, which provide additional funds for fleet management, office space, a new vehicle, and personnel reclassification. Also included in this bill is a onetime FY 2022 supplemental appropriation, which provides for a technical audit.
