RS 29120:	Vice Chairman Syme presented RS 29120 explaining that it would freeze unemployment insurance at the current rates.
	Jani Revier, Director of the Idaho Department of Labor, further explained that RS 29120 would freeze the base unemployment insurance rate at the 2021 level for both 2022 and 2023. This would save a total of 64 million dollars for Idaho businesses without affecting the General Fund as this pertains to the Unemployment Insurance Trust Fund. This Trust Fund would still have enough money to remain solvent with the 64 million dollars of decreased revenue.
	In response to questions, Ms. Revier explained that unemployment insurance rates are set on an annual basis for an entire year. The Department of Labor sends new tax notifications yearly. They would provide any businesses that had already paid a higher rate with a refund or credit.
MOTION:	Rep. Horman made a motion to introduce RS 29120. Motion carried by voice vote.
	Chairman Holtzclaw introduced the Committee Secretary, Emily Huddleston , and new Page for the first half of the session, Audrey Payne .

Chairman Holtzclaw called the meeting to order at 1:29pm.

Chairman Holtzclaw assigned proofreading duties to Rep. Kingsley and Rep.

Necochea.

RS 29035: Rep. Syme introduced RS 29035, explaining that it would increase the price limit

for delegation of public works projects.

Keith Reynolds, Director of the Department of Administration, discussed how the delegation of projects is requested by agencies based on their in-house project management capabilities. Currently any projects costing more than 150,000 dollars have to be overseen by the Permanent Building Fund Advisory Committee. The proposed legislation would increase the limit from 150,000 dollars to 300,000 dollars. The current limit was set in 1996; adjusted for inflation would be 276,000 dollars which was rounded to 300,000 dollars.

In response to questions, **Mr. Reynolds** explained that a similar piece of legislation had been brought before the committee last year, but the previous proposed limit

was 500,000 dollars.

MOTION: Rep. Weber made a motion to introduce RS 29035. Motion carried by voice vote.

RS 29205: Rep. Monks explained that RS 29205 would require any injury an employee suffers

from an employer mandated COVID-19 vaccine to be compensable under workers compensation. Under the current system, some claims are being paid out while others are not. This legislation would clarify that such injuries would be covered.

In response to questions about whether this would prevent employees from seeking other civil action, **Rep. Monks** said that, like all workers compensation, it is an exclusive remedy but that doesn't necessarily prevent people from pursuing other legal action.

In response to questions about concerns from businesses, **Rep. Monks** explained that he believes this language will not have opposition.

In response to further questions, **Rep. Monks** said he believed that injury would

include death.

MOTION: Rep. Christensen made a motion to introduce RS 29205. Motion carried by

voice vote.

Rick Ferguson, CEO of the Idaho State Insurance Fund, discussed the Idaho State Insurance Fund's (SIF) role in worker's compensation. Beginning with the industrial revolution, companies began paying for work related injuries. In return, the workers gave up the right to sue. Insurance funds take employer premiums, hold them in trust, and pay out when injuries occur. SIF provides a reliable and competitive source of worker's compensation, and is especially popular among small businesses. SIF underwrites high risk businesses and government organizations. They earn a profit from the investment income from capital held in trust and therefore receive no funds from taxpayer dollars. This is better done by a public agency than by the private sector because private companies would charge higher rates due to the high risk nature of the businesses. To remain viable, SIF needs to modernize and remove statutory language requiring use of government agencies for accounting and payroll.

In response to questions, **Mr. Ferguson** said that SIF's market share is 55%.

Chairman Holtzclaw called the meeting to order at 1:30pm.

MOTION: Rep. Kingsley made a motion to approve the minutes January 19, 2022. Motion

carried by voice vote.

MOTION: Rep. Kingsley made a motion to approve the minutes January 25, 2022. **Motion**

carried by voice vote.

H 450: Rep. Syme explained that H 450 freezes the base rate of unemployment insurance

rates charged to businesses. The base rate is determined by the 3 years with the highest cost in the last 20 years. Freezing the rate at 2021 levels will save businesses 64 million dollars. It will cost the Unemployment Insurance Trust Fund

64 million dollars over the next two years.

In response to questions about the sustainability of the fund, **Rep. Syme** said the Unemployment Insurance Trust Fund has adequate supplies so long as nothing catastrophic happens in the next two years. He further explained that the Department of Labor initiated this legislation to prevent the government from

charging businesses more for unemployment insurance was needed.

Jani Revier, Director of the Department of Labor, testified that freezing the unemployment insurance now would prevent businesses from facing an unnecessary increase in the rates. Last year the rates decreased because 200 million dollars was allocated to cover pandemic costs. Without that additional money, this year's rates would increase substantially due to the high cost years. However, because of the way the formula for determining the unemployment insurance rate works, the rates will drop after 2023. Therefore, freezing the rate at

the 2021 level would prevent unnecessary costs to businesses.

Salvador Vazquez, Labor Market Information Director for the Idaho Department of Labor, explained the methodology behind the formula which determines the

unemployment insurance rate.

MOTION: Rep. McCann made a motion to send H 450 to floor with aDO PASS

recommendation. Motion carried by voice vote. Rep. Syme will sponsor the bill

on the floor.

Chairman Holtzclaw turned the gavel over to Vice Chairman Syme.

RS 29056C1: Chairman Holtzclaw explained that RS 29056C1 would allow Idaho government

agencies to reimburse hard working agency employees. Any agency employee with 1040 hours or more would be able to be reimbursed for education by the agency.

In response to questions, **Chairman Holtzclaw** clarified that 1040 hours is roughly 6 months of work. Additionally, this legislation would expand a similar program to all agency employees.

Lori Wolff, Administrator for the Division of Human Resources, explained that when an agency enters into an agreement to help an employee pay for education in return for that employee working for the agency for a certain period of time and that agreement is broken by the employee, the clawback provision in this legislation allows that agency to regain the lost funds.

In response to questions, **Ms. Wolff** said that no cost is seen in the fiscal note because agencies must use existing funding or go through the Joint Finance and Appropriations Committee for funding. These would be considered on a case by case basis. The agreement is made with the director of the agency and that agency determines what funding is available for how long the employee must remain.

Ms. Wolff clarified that the current program is limited to specific professions and is a loan repayment program while this would be a reimbursement program for all agencies, allowing for more flexibility.

In response to concerns that this would create growing additional costs, **Ms. Wolff** explained the legislature would have control over all additional funding.

In response to further questions, **Ms. Wolff** said a requirement for consistency of the years of work required for education payment was not included in the legislation because agreements differ on the amount of education they cover and therefore the number of years served must also fluctuate. However, the Division of Human Resources would oversee the agreements to ensure consistency. Additionally, maximum budgetary limits were not included because this would be covered in administrative rules.

Chairman Holtzclaw explained that they are seeking to give agencies another tool to retain employees without causing an excessive drain on the budget.

Rep. Necochea made a motion to introduce **RS 29056C1**. **Motion carried by voice vote. Reps. Hanks**, **Christensen**, and **Wisniewski** requested to be recorded as voting **NAY**.

Chairman Holtzclaw called the meeting to order at 1:30pm.

H 464: Rep. Skaug said H 464 would allow anyone injured by the COVID

Rep. Skaug said **H 464** would allow anyone injured by the COVID-19 vaccine to receive compensation if it was required by the employer. He explained that, working in worker's compensation, he has seen many such claims. He clarified that this legislation would not codify a vaccine requirement. The goal is simply to make sure

those people who do get injured are covered under worker's compensation.

In response to questions about how this is related to a vaccine mandate, **Rep. Skaug** said this would not function as a mandate but would simply provide coverage. In addition, it would lessen litigation because insurance companies

would know they have to cover it without going to court.

In response to questions about how this would increase the cost for all companies to provide worker's compensation, whether or not they require vaccine, **Rep.**Skaug said he didn't believe it will increase the cost enough to increase premiums.

Craig Campbell, a Boise resident, spoke against **H 464** saying people have Constitutional rights to equal protections and personal freedom. He argued this legislation violates the Constitution because it allows businesses to require vaccines. He questioned how damages would be determined and who would be qualified to put a price on the loss of someone's quality of life. By legislating how vaccine requirements function it would codify vaccine mandates.

In response to questions, **Mr. Campbell** said **H 464** codifies vaccine mandates because it goes along with the status quo. It presupposes the right of businesses to mandate vaccines.

Sarah Clendenon, a representative of Health Freedom Idaho, spoke against **H 464** explaining there is already a federal program for vaccine injury reporting which refuses to admit vaccine injuries that do occur. Making such injuries compensable will not accomplish anything because no one will ever be able to prove the injury was caused by the vaccine. She argued that the use of the word 'when' in the bill indicates businesses have the right to enforce a vaccine mandate. This bill would take away people's rights under the guise of helping them.

Cece Andrews said businesses and the legislature do not have the right to violate inherent rights like privacy and bodily autonomy.

Miste Karlfeldt, a representative of Health Freedom Idaho, also testified against **H 464** and said the crux of the problem is that individual's medical decisions should not be made by business. She raised concerns about how the cost of the injury would be determined and how, supposing payouts actually occur, this would skyrocket premiums and harm small businesses.

Alex LaBeau, President of the Idaho Association of Commerce and Industry, testified in favor of **H 464** and explaining how this legislation would allow injured employees to get compensation. He said this would be a fair process and requires less evidence than a court and payouts are received much faster.

In response to questions about whether employers or the federal government should be liable, **Rep. Skaug** said the federal government should be the one held responsible but Congress would not follow through with this.

Rep. Skaug closed by saying this legislation is not for or against COVID-19 vaccines. This is just to get compensation for those who are injured. The current system needs clarification because some claims get paid out while others are denied. This bill would ensure those who need it get compensation.

In response to questions about whether this would cover those who have no objection to getting vaccinated, **Rep. Skaug** explained this covers anyone who works for an employer who requires a vaccine whether they are for or against it.

MOTION:

Rep. Toone made a motion to send **H 464** to the floor with a **DO PASS** recommendation. **Motion carried by voice vote**. **Reps. Hanks**, **Kingsley**, **Wisniewski**, and **Christensen** requested to be recorded as voting **NAY**. **Rep. Skaug** will sponsor the bill on the floor.

Chairman Holtzclaw brought matters regarding ARPA funding to the committees attention and explained that a concurrent resolution will be needed to guide how those funds will be spent. He informed them there will be a presentation on the matter on Thursday.

DOCKET NO. 17-0000-2100F: **Sonnet Robinson**, Idaho Industrial Commission, Rules Review Officer, said the only changes to the administrative rules were in regards to worker's compensation claims reporting requirements. They received no negative feedback from stakeholders. The other proposed rule has been struck and will be reverted back to the original rule was accepted by legislature last year.

MOTION:

Rep. Harris made a motion to approve **Docket No. 17-0000-2100F**. **Motion** carried by voice vote.

DOCKET NO. 21-0000-2100F: **Mark Tschampl**, Chief Administrator, Idaho Division of Veterans Services, said there were no changes to the fee rules governing the admission, residency, and maintenance charges in Idaho veterans homes. There is a minor increase in fees for the preparation internment sites. This increased from five to seven hundred dollars due to increased costs. Additionally, changes were made to eligibility requirements for burial as well as rules governing public behavior at the cemetery.

In response to questions, **Mr. Tschampl** said the seven hundred dollar fee is paid for by the families seeking to inter their loved one in the cemetery. Further, the increase from five to seven hundred dollars is due to the increased cost of labor and supplies since it was last increased nine years ago.

This legislation would allow SIF to transition out of state vacation and sick leave programs and adopt Paid Time Off and holidays more consistent with the private sector. Additionally, this legislation would allow SIF to digitize its financial transaction offerings through mobile service applications and online banking, without the need to go through the State Controller's Office and Treasurer's Office. An independent audit and the Department of Insurance provide oversight, making the additional steps of going through the Controller and

Treasurer unnecessary.

In response to questions about transparency, **Rep. Gestrin** said SIF keeps its accounting information and payroll on Transparent Idaho to ensure transparency.

MOTION: Rep. Syme made a motion to introduce RS 29325. Motion carried by voice vote.

DOCKET NO. 15-0400-2100:

Michelle Peugh, Strategic Business Partner for Division of Human Resources, came to present **Docket No. 15-0400-2100**. The committee requested a red lined

version of the rules.

Chairman Holtzclaw put the meeting at ease at 1:38pm.

Chairman Holtzclaw called the meeting back to order at 1:39pm.

Review of **Docket No. 15-0400-2100** was postponed until Monday, February 7, 2022.

Alex Adams, Administrator of the Division of Financial Management, explained the Governor's recommendations for the use of federally provided ARPA funding. The first recommendation which Mr. Adams presented was fifty million dollars toward workforce housing, twenty percent of which would be designated for rural areas. Traditionally this is paid for through federal credits and private financing, but there is currently a financing gap which could be closed with ARPA funding. This would allow for the development of one thousand new rental units. Secondly, it is proposed to allocate fifty million dollars toward child care expansion grants with the goal to increase childcare spots by two thousand. Thirdly, one million dollars would be allocated towards food bank support to continue to provide meals to those in need. Fourthly, workforce training programs would receive fifty million dollars. These programs would be overseen by the Workforce Development Council with the goal of preparing a workforce for in-demand professions. Finally, twenty five

million dollars would be used to expand the Idaho State Health Insurance Reserves. Due to the high number of claims because of COVID-19, additional funds are needed to cover the costs of state employees. This investment would keep the reserves at the 95th percentile and reduce reliance on the general fund.

In response to questions about how close this places the State Health Insurance Reserves to the federally allowable gap, **Mr. Adams** said this would put Idaho over that limit but it was not a hard and fast limit. However, because of the pandemic, there has been more flexibility in how much is allowed in insurance reserves and this would ensure Idaho has maximum options.

In response to how the funds for expanding childcare could be used to assist entrepreneurial moms who provide childcare from their homes, **Wendy Seacrest**, Executive Director of the Idaho Workforce Development Council, said they were considering designating a portion of the funds to small providers or putting a cap on the number of seats for which any one applicant could apply.

In response to questions about collaboration with colleges, **Ms. Seacrest** said they currently work with career technical colleges, private providers, and anyone who provides needed training.

Chairman Holtzclaw explained that four House Concurrent Resolutions covering these topics would be before the committee next week.

MOTION: Rep. Necochea made a motion to approve the minutes of January 31 and February

1, 2022. Motion carried by voice vote.

ADJOURN: There being no further business to come before the committee, the meeting

adjourned at 2:03pm.

RS 29124: Rep. Dixon said RS 29124 would create hazard pay for wildland firefighters. It

would allow the Idaho Department of Lands to increase the differential pay of wildland firefighters by 25% when in hazardous conditions, making it easier for

Idaho to attract employees to this in-demand profession.

MOTION: Rep. Syme made a motion to introduce RS 29124. Motion carried by voice vote.

RS 29135: Rep. Erickson explained RS 29135 would add juvenile detention, juvenile

probation, and adult misdemeanor post-certified officers to the Rule of 80 retirement plan as is currently conducted with their adult counterparts. This would help with recruitment efforts for positions that work with high risk youth and is specifically for post-certified positions so not everyone would be able to take advantage of this.

MOTION: Rep. Weber made a motion to introduce RS 29135. Motion carried by voice vote.

RS 29396: Rep. Skaug declared Rule 80 before explaining RS 29396 seeks to streamline

workers' compensation settlement process for employers and injured workers who choose to settle their respective claims, rather than go to hearing. It would eliminate the requirement of approval of the Industrial Commissioners, except for settlements involving minors, legally incompetent persons, or when either party is

not represented by an attorney.

MOTION: Rep. Toone made a motion to introduce RS 29396. Motion carried by voice vote.

RS 29489: Rep. Skaug again declared Rule 80 before introducing RS 29489 which ensures

that COVID-19 vaccine injuries are compensable under workers' compensation. This legislation replaces an RS previously heard by the committee and improves it by explaining this legislation is not for or against COVID-19 vaccine requirements

Currently, the Governor's office seeks out applicants to apply for this position. This legislation would place responsibility for recruitment of applicants, processing applications and doing initial interviews of applicants with the Judicial Council with assistance from the Idaho State Bar. The Judicial Council would use the same process they currently use with candidates for open district judge and appellate judge positions. At the end of its process, the Judicial Council would present two to four names to the Governor for his consideration for appointment as the attorney representative to the Industrial Commission.

In response to questions about the opinion of the Governor's office, **Rep. Ruchti** explained that they haven't taken a position though they have been informed. Additionally, he said he was unaware of any other situation in which this process is used to select candidates other than district and appellate court judges.

MOTION:

Rep. Necochea made a motion to introduce RS 29194. Motion carried by voice vote.

RS 29413C1:

Rep. Syme said RS 29413C1 would set up an Idaho Workforce Housing Advisory Commission and establish the Idaho Workforce Housing Fund. It would not authorize additional spending; it would just set up the mechanism to create a fund. The Advisory Commission would consist of 10 members and be tasked with developing, implementing, and maintaining a statewide workforce housing plan. The Idaho Workforce Housing Fund would be created to accept such monies as allocated by the legislature and distribute funds according to the statewide plan as implemented by the Idaho Workforce Housing Commission Distinct shortage of housing for workforce. Rep. Syme also pointed out in paragraph 2 the word 'Association' should be changed to say 'The Idaho Housing and Finance Association'.

Rep. McCann made a motion to introduce **RS 29413C1** with the following changes: on Page 2, Section 2, Paragraph 2, change the word "association" to "The Idaho Housing and Finance Association". **Motion carried by voice vote.**

RS 29453:

Rep. McCann explained **RS 29453** would add clarification on how state law is applied to all state employees, while also clarifying which sections of Idaho's personnel system laws apply to classified employees. Adding inclusive language to include "classified and nonclassified state employees" will help to ensure employee best practice standards are applied across all state employees in the executive department and provide a foundation for decisions and policies. The changes will further clarify that only classified state employees are subject to the merit system and due process.

RS 29473:

Rep. McCann explained **RS 29473** would allow for flexibility and clarification within established compensation practices. In response to questions about the increased maximum bonus from two to five thousand dollars, **Rep. McCann** said that they wanted the ability to increase the maximum bonus if it was deserved. There was no change in the fiscal note because these bonuses must still come from the existing budget.

Chairman Holtzclaw called the meeting to order at 1:30pm.

MOTION: Rep. Kingsley made a motion to approve the minutes of February 9, 2022. **Motion**

carried by voice vote.

Aaron White, Commissioner and Chairman of the Idaho Industrial Commission explained that the Commission began as the Industrial Accident Board because of the alarming rates of workplace injuries after the Industrial Revolution. It now consists of three commissioners: one represents labor, one employers, and the third is an attorney representative. They are funded by a two percent tax on insurance premiums. The Commission administers and regulates the workers' compensation system. They help employers understand workers' compensation law and implement it, resolve informal disputes, approve lump sum settlement agreements, and return injured workers to work. They also have an Advisory Committee which has sixteen members who represent everyone affected by workers' compensation. Finally, the Crime Victims Compensation Program provides financial assistance to innocent victims of crime.

In response to questions, **Mr. White** said that they are able to completely cover the cost of forensic examinations for victims of sexual assault.

In response to questions about the Commission's role in resolving disputes, **Mr. White** said the Commission reviews settlements to ensure that they are in the best interest of all parties. Once a settlement has been reached, the injured worker cannot claim further expenses from the injury in the future. The Commission makes sure the worker is aware of this before accepting settlements.

Thomas Baskin, Commissioner and Attorney Representative of the Idaho Industrial Commission, explained subrogation as a situation where there has been a denial of certain medical care for a work injury so the claimant pays for the care via health insurance. At some point in the future, the workers' compensation pays out and the insurance company wants to be reimbursed for the cost of the medical care. The Industrial Commission must ensure that these situation are thoroughly investigated prior to approving the settlement.

DOCKET NO. 17-0000-2100:

Sonnet Robinson, Idaho Industrial Commission, Referee, Rules Review Officer, presented **Docket No. 17-0000-2100** explaining that there have been no changes to these rules since they were last reviewed by the committee.

MOTION: Rep. Syme made a motion to approve Docket No. 17-0000-2100. Motion carried

by voice vote.

H 551: Rep. Syme explained H 551 would allow the PERSI board to have the right to subpoena bank records to discover where the retirement money is being deposited after the intended recipient has died. MOTION: Rep. McCann made a motion to send H 551 to the floor with a DO PASS recommendation. Motion carried by voice vote. Rep. Syme will sponsor the bill on the floor. H 552: Rep. Syme said H 552 increases the time period that a political subdivision can stay on PERSI. Currently, if their average membership decreases by twenty five members or twenty five percent, they have to be removed from PERSI. Due to current staffing shortages, this bill would allow these political subdivisions more time to increase membership before they are removed. H 552 also changes the word liability to penalty because the term penalty provides for better standing during bankruptcy proceedings. MOTION: Rep. McCann made a motion to send H 552 to the floor with a DO PASS recommendation. Motion carried by voice vote. Rep. Syme will sponsor the bill on the floor. H 553: Rep. Syme explained H 553 authorizes PERSI to have FBI background checks done on employees who have access to sensitive information. MOTION: Rep. Chairman Holtzclaw called the meeting to order at 1:30pm.

DOCKET NO. Ewa Szewczyk, Rules Review Officer, Idaho Department of Commerce presented

28-0000-2100: Docket No. 28-0000-2100 and explained there have been no changes since these

rules were last reviewed by the legislature.

MOTION: Rep. Weber made a motion to approve Docket No. 28-0000-2100. Motion

carried by voice vote.

H 589: Rep. Erickson explained H 589 would add juvenile detention officers, juvenile

probation officers, and adult misdemeanor probation officers to the list of police officer members eligible for Rule of 80 retirement. These officers go through very intense training and are POST-certified. There are currently many positions which qualify for Rule of 80 which do not face extreme risk; these officers are out in the field facing potentially dangerous situations. Additionally, the cost increases would

not be prohibitive.

In response to questions about the opinion of the counties, Rep. Erickson said that

reports from these professionals indicate that the counties are on board.

Don Drum, Executive Director of PERSI, explained this change could have both positive or negative effects on the overall cost of the benefits. It should not cost additional money because the cost is covered by the employees receiving the benefits, however, with more people paying in, it may cost less. There is still the

possibility that it will cause an increase in rates over time.

In response to questions about whether there is a buy in when changing from Rule of 90 to Rule of 80, **Director Drum** said there is not as the change is not retroactive. Those who make the change in the middle of their career will be mixed

and end up somewhere between Rule of 80 and Rule of 90.

Brian Walker, Director of 3-B Juvenile Detention Center, spoke in support of **H 589** as these are POST-certified officers who go through the same vetting system as other officers. They perform the same tasks those in the adult system do, often dealing with the same types of crimes and facing the same risks. In order to maintain employees, they need to be able to compete by offering similar benefits. In the last year, Mr. Walker said five out of the fourteen employees in his facility left.

MOTION: Rep. McCann made a motion to send H 589 to the floor with a DO PASS

recommendation. Motion carried by voice vote. Rep. Erickson will sponsor

the bill on the floor.

H 594:

Rep. Horman said **H 594** would amend and repeal existing law to provide for consistency of terminology with respect to state employees. Adding inclusive language to include "classified and nonclassified state employees" will help to ensure employee best practice standards are applied across all state employees in the executive department and provide a foundation for decisions and policies. The changes will further clarify that only classified state employees are subject to the merit system and due process.

In response to questions about how this will affect universities, **Rep. Horman** explained there will be specific policies to ensure the board can work with these institutions to conform to state law.

MOTION:

Rep. Weber made a motion to send **H 594** to the floor with a **DO PASS** recommendation. **Motion carried by voice vote. Rep. Horman** will sponsor the bill on the floor.

H 554:

Rep. Syme said **H 554** clarifies the definition of early retirement in certain sections of Idaho Code as retirement prior to age sixty for police officers or sixty-five for general members while having fulfilled their Rule of 80. If someone retires early prior to reaching the Rule of 80 then they will experience deductions from their benefits.

In response to questions about a distinction between the different rules, **Director Drum** said police officers operate under service requirements which allows them to retire at age sixty with full benefits regardless of whether they have reached their Rule of 80 requirements.

MOTION:

Rep. Horman made a motion to send **H 554** to the floor with a **DO PASS** recommendation. **Motion carried by voice vote**. **Rep. Syme** will sponsor the bill on the floor.

H 463:

Rep. Syme explained **H 463** amends existing law to increase the authorized cost limit for the delegation of public works projects from one hundred fifty thousand dollars to three hundred thousand dollars. If the agency has sufficient capabilities, they can request oversight of the project be delegated to the agency by the Permanent Building Fund Advisory Council.

MOTION:

Rep. McCann made a motion to send **H 463** to the floor with a **DO PASS** recommendation. **Motion carried by voice vote**. **Rep. Syme** will sponsor the bill on the floor.

H 595:

Rep. McCann said **H 595** would amend existing law to provide for compensation increases based on performance as well as consideration of certain internal and external factors. Current policy restricts agencies' ability to be competitive when filling positions because employees can't receive raises without a performance evaluation. This legislation would allow them to be raised up to market value even before this evaluation as well as increase the maximum performance bonus from two thousand to five thousand dollars. This would give flexibility to agency directors to allow for better recruitment and retention of employees.

In response to questions about this requiring additional appropriations in the future, **Lori Wolff**, Administrator, Division of Human Resources explained this would simply increase the allowed performance bonus to the same level as the recruitment and retention bonuses. Additionally, agencies must already have room in their existing budget for these bonuses and all of these must be approved by the Division of Human Resources and the Division of Financial Management. This would not be a massive financial commitment because these bonuses will not be given to all employees, just to hard-to-fill positions.

Michelle Peugh, Strategic Business Partner, Division of Human Resources explained equity adjustments would be given when wage compression occurs prior to the employee's first performance evaluation. This legislation would allow them to be brought up to current market values. This would be within the limits of the pay grade and would never be raised above the salaries of the employee's peers.

Ms. Wolff said the funding for these bonuses and equity adjustments would come from salary savings. Agencies are given appropriations based on the number of positions they have. When these positions are not filled, the agency experiences salary savings from not paying wages for these positions. These savings are already within the agency's budget designated to be spent on personnel. This legislation would simply give directors more flexibility on how these funds are spent allowing them to be more competitive in the job market and retain the best employees.

MOTION:

Rep. Weber made a motion to send **H 595** to the floor with a **DO PASS** recommendation.

Rep. Harris expressed concerns that this would creates tremendous pressure for agencies to increase personnel spending. There may not be a major fiscal impact the first year but there will be pressure to increase the budget later on.

Rep. McCann clarified they are not asking to raise budgets but to give the directors the ability to fill necessary positions with money not being spent on salaries.

Rep. Necochea reminded the committee the legislature is still in control of appropriations and this would give agencies a tool to help fill necessary positions.

ROLL CALL VOTE:

Rep. Hanks requested a roll call vote on H 595. Motion failed by a vote of 6 AYE and 7 NAY. Voting in favor of the motion: Reps. Syme, Weber, McCann, Chew, Necochea, and Toone. Voting in opposition to the motion: Reps. Harris, Kingsley. Christensen. Wisniewski. Horman. Hanks. and Holtzclaw.

Chairman Holtzclaw called the meeting to order at 3:11pm.

Chairman Holtzclaw introduced the new Page for the second half of the session,

Elijah Zeller.

H 555: Rep. Horman explained H 555 would correct an imbalance in the PERSI

contribution rate for school employees. This occurs because these individuals usually live longer and retire later. If this legislation is enacted, the PERSI board would consider adjusting the contribution rates so the general members would no longer bear the cost of filling in this gap. Also, this legislation would create a short-term solution for dealing with the workforce shortage by allowing retirees to

be rehired in a cost neutral way.

Don Drum, Executive Director of PERSI, explained this is different than the current return to work program because it sunsets in 2026 and only allows individuals who retired prior to January, 2021, to take advantage of this program. This would prevent the costs of changing retirement patterns seen in other return to work programs.

In response to questions about individuals with two relevant occupations, **Director Drum** said that rates would be determined based on their primary job. If their

primary job is teaching, then they will be under the new teacher rates.

MOTION: Rep. Toone made a motion to send H 555 to the floor with a DO PASS

recommendation. Motion carried by voice vote. Rep. Horman will sponsor

the bill on the floor.

H 588: Rep. Dixon presented H 588 which would allow for differential pay for wildland

firefighters. Firefighter pay in Idaho is currently not competitive with neighbor states which makes retaining employees difficult. Paying these individuals a higher rate

when they face extreme hazards will help retain valuable employees.

Scott Phillips, Policy and Communications Chief, Idaho Department of Lands, explained employee turnover is not just bad, it is very dangerous. It is vital for everyone's safety that these individuals are experienced and constant turnover

leaves these positions vulnerable.

Murphy Olmstad, Lobbyist representing The Southern Idaho Timber Protective Association and the Clearwater-Potlatch Timber Protection Association, and **Jeremy Chou**, Lobbyist representing Stella Jones, spoke **in support** of **H 588**

because of the need for recruitment and retention of employees.

MOTION:

Rep. Necochea made a motion to send **H 588** to the floor with a **DO PASS** recommendation. **Motion carried by voice vote**. **Rep. Dixon** will sponsor the bill on the floor.

H 592:

Rep. Syme explained **H 592** which would attempt to close the gap in funding that exists in developing affordable housing. This legislation does not spend money but would simply create an Idaho Workforce Housing Fund and a corresponding Idaho Workforce Housing Advisory Commission. The fund would be a mechanism to spend any monies appropriated for workforce housing and the commission would develop a plan for how these monies would be spent.

In response to questions about the use of American Rescue Plan Act (ARPA) funding, **Rep. Syme** stressed that this legislation was not about spending money but about creating a mechanism for it to be spent, regardless of where those funds come from. ARPA funding could be used, but it is not necessary and not mentioned because the legislature would approve any money regardless of where it comes from.

In response to questions about how much setting up the Idaho Workforce Housing Advisory Commission would cost, **Rep. Syme** said they would not receive compensation unless they were required to travel and then there would be a small cost.

In response to questions about the possibility of creating incentives for local communities to spend more money because of a provision for fund matching, **Rep.**Syme said the fund matching is not restricted to money; the match can be in land, waiving of development fees, or other forms.

MOTION:

Rep. Weber made a motion to send **H 592** to the floor with a **DO PASS** recommendation.

Alex Adams, Administrator for the Division of Financial Management, explained the federal requirements attached to accepting ARPA funding include encouraging contractors to wear seatbelts, encouraging them not to text while drawing, and to direct the money towards individuals at or below eighty percent of the median income.

Jim Foudy, Superintendent Blaine County School District, **Caleb Roope**, President and CEO of The Pacific Companies, **Liza Leonard**, Director of Public Affairs, Ball Ventures, **Ellen Ganz**, Mountain Central Association of Realtors, all spoke **in support** of **H 592** because of the need for housing with a rapidly expanding population. This would assist with solving the employee shortage and boost the economy by creating development jobs.

Fred Birnbaum, Legislative Affairs Director, Idaho Freedom Foundation, spoke **in opposition** to **H 592**. The current affordable housing crisis exists because the federal government policies of injecting trillions of dollars into the economy and suppressing interest rates has driven asset inflation and increased housing costs. Additional government involvement historically has never solved this problem. It is disingenuous to say that this legislation would exist apart from the ARPA funding. In the future, when the ARPA funding has run out, this fund will still need money on an ongoing basis and this will likely come from the General Fund.

In response to questions about previous examples of government involvement in affordable housing, **Mr. Birnbaum** said in 2008 and 2009 a huge inflationary housing bubble was created by federal policies. Specifically, artificially low interest rates led to speculation in the housing market which ultimately set the stage for the crash.

Rep. Syme said **H 592** would help solve a significant problem when no other solutions have been presented.

ROLL CALL VOTE:

Rep. Christensen requested a roll call vote on H 592. Motion carried by a vote of 8 AYE, 4 NAY, and 1 Absent/Excused. Voting in favor of the motion: Reps. Syme, Horman, Weber, McCann, Chew, Necochea, Toone, and Holtzclaw. Voting in opposition to the motion: Reps. Harris, Christensen, Wisniewski, and Hanks. Rep. Kingsley was absent/excused. Rep. Syme will sponsor the bill on the floor.

Chairman Holtzclaw called the meeting to order at 2:45pm.

MOTION: Rep. Necochea made a motion to approve the minutes of February 15 and

February 17, 2022. Motion carried by voice vote.

H 590: Rep. Skaug declared Rule 80 before explaining H 590 which would allow the

interested parties to settle agreements without the approval of the Idaho Industrial Commission. As it currently stands, the Industrial Commission must approve every settlement and can choose to reject them if they deem it not in the best interest of all parties. This unnecessarily delays payments to individuals and hospitals. This legislation would still require the Commission's approval in cases involving children,

legally incompetent persons, and those not represented by an attorney.

Rep. Ruchti explained they had been unable to reach a consensus with the Industrial Commission but the delays caused by requiring the Commission's approval are harmful and unnecessary when all parties have already agreed to

the best solution.

Andrew and Stephanie Mickelsen, Mickelsen Farms, Chyla Wilson, Idaho Farm Bureau Federation, and Matt Andrew, Michael McBride, James Arnold, Michael McPeek, and Andy Adams, attorneys working in workers' compensation, all testified in support of H 590. They said the current process creates long delays that leave injured workers without compensation during critical periods. Furthermore, the Commission's approval is not needed because the attorneys are responsible for ensuring their clients' best interests. If they fail in this or in adequately sorting out matters of subrogation, then they as attorneys are liable. It is unnecessary to have a government organization mediate private agreements.

In response to questions about the average time to receive approval from the Commission, **Mr. Andrew** said it takes two to six weeks on average but they have seen an increase in the number of cases that take months.

Joe Maloney, President of the American Federation of Labor and Congress of Industrial Organizations, testified **in opposition** to **H 590**, saying this legislation is too drastic and they wished to support the Idaho Industrial Commission.

Chairman Holtzclaw put the committee at ease at 3:40pm.

Chairman Holtzclaw called the committee back to order at 3:41pm.

MOTION: Rep. Christensen made a motion to send H 590 to the floor with a DO PASS

recommendation.

SUBSTITUTE MOTION:

Rep. Chew made a substitute motion to **HOLD H 590** in committee.

ROLL CALL ON SUBSTITUTE MOTION:

H 670:

Rep. Skaug explained **H 670** which would give the legislature approval power over the acceptance of federal unemployment benefits with certain exceptions.

In response to questions about whether the acceptance of benefits would require the legislature to be in session, **Rep. Skaug** said the governor would be allowed to accept the benefits but that this decision would be able to be reviewed by the legislature when they return to session.

Chairman Holtzclaw put the committee at ease at 4:08pm. **Chairman Holtzclaw** called the meeting to order at 4:11pm

After concerns were raised about whether the governor would be allowed to issue special or standing orders in these situations and the effect this legislation would have on the Department of Labor, **Rep. Skaug** requested that the committee hold **H 670** in committee.

MOTION:

Rep. McCann made a motion to **HOLD H 670 in** committee. **Motion carried** by voice vote.

H 667:

Rep. Mitchell introduced **H 667** which would protect the unemployment system by giving guidance to the Department of Labor on how to verify unemployment claims. Most of these actions are already being taken, this would simply codify it for the future. Additionally, this would require a report to be given to the germane committee on what has happened throughout the year.

In response to questions about the legislation's origin, **Rep. Mitchell** said this legislation exists because of the number fraudulent claims, but it would also create trust and ensure that the unemployment system continues to run smoothly.

In response to questions about how this would affect the Department of Labor, Jani Revier, Director of the Department of Labor, said the Department takes fraud seriously and has many checks in place to prevent it from happening. Most of the actions required by this legislation are already being completed, however, it could negatively affect the Department's flexibility in dealing with individual situations, their right to waive overpayments, and their ability to remain in conformity with federal requirements. Additionally, this legislation could act as a blueprint of the Department's practices which people could use to create more elaborate fraud schemes.

MOTION:

Rep. Horman made a motion to send **H 667** to the floor with a **DO PASS** recommendation.

SUBSTITUTE MOTION:

Rep. Syme made a substitute motion to **HOLD H 667** in committee.

Rep. Toone expressed reservations about passing **H 667** until it has been fully vetted by the Department of Labor.

ROLL CALL Rep. Hanks requested a roll call vote on H 667. Substitute motion failed by a **VOTE ON** vote of 5 AYE, 7 NAY, and 1 Absent/Excused. Voting in favor of the motion: SUBSTITUTE Reps. Syme, Chew, Necochea, Toone, and Holtzclaw. Voting in opposition to MOTION: the motion: Reps. Kingsley, Christensen, Wisniewski, Horman, Hanks, Weber, and McCann. Rep. Harris was absent/excused. Roll call vote was requested. Motion carried by a vote of 8 AYE, 4 NAY, and 1 ROLL CALL VOTE ON Absent/Excused, Voting in favor of the motion: Reps. Kingsley, Christensen. H 591: Rep. Ruchti explained H 591 would improve the process by which the governor

appoints the attorney representative on the Idaho Industrial Commission. Currently, the governor seeks applicants by asking for recommendations and accepting applications. In order to get the best candidates for the position, there needs to be better advertising. This legislation would enact the same process used to appoint judges by going through the Idaho Judicial Council. Notice of the application would be sent out across the entire state, surveys would be taken, and promising candidates would be interviewed thereby collecting more information than the current hiring process. A few candidates would then be selected and their names

would be passed on to the governor to make the final decision.

MOTION: Rep. McCann made a motion to send H 591 to the floor with a DO PASS

recommendation. Motion carried by voice vote. Rep. Ruchti will sponsor the bill

on the floor.

H 701: Jeremy Pisca, lobbyist representing the Idaho Realtors, Northwest Credit Union

Association, and the Idaho Housing and Finance Association said **H 701** replaced **H 592**. The changes made to this legislation include removal of the provisions creating the Idaho Workforce Housing Advisory Commission and the addition of a sunset clause which would cause this legislation to expire after the American

Rescue Plan Act funds have been expended.

MOTION: Rep. Toone made a motion to send H 701 to the floor with a DO PASS

recommendation.

Rep. Wisniewski spoke **in opposition** to **H 701** because, while there is a shortage of labor force and housing, this is caused by federal and state policies. Government created these problems and is now trying to fix it by spending more money taken

from someone else.

Rep. McCann voiced her support of the motion because as the housing market adjusts to the high rates of growth in Idaho, there are many who need assistance

in finding housing.
