**Chairman Crane** called the meeting to order at 9:02 a.m.

Chairman Crane reviewed the committee rules.

RS 29116: Rep. Ehardt presented RS 29116, which will change the manner in which school

board trustees fill vacated positions caused by a recall. Currently, the Board can choose who would permanently fill the vacated seat and this could negatively impact the community as the permanent trustee has not been voted into position. **RS 29116** states that if a regularly scheduled election date is coming within 90 days of a successful recall, the vacated position should remain open until the election, which allows candidates to run for the seat. If the election is further than 90 days away, the vacated trustee position can be filled by the School Board or Board of County Commissioners as a temporary position only and the permanent seat will

be decided by the voters at the next possible election cycle.

In response to committee questions, **Rep. Ehardt** said this proposed change had been presented to the public and had received no opposition. The reason it was not already in place was the proposed legislation was presented late in an earlier session and had to be pushed to a later date. In response to additional committee questions, Rep. Ehardt confirmed the proposed legislation would not impact the General Fund and that the specified time frames of 90 days would be updated to

reflect the updated specified time frames in current legislation.

MOTION: Rep. Hanks made a motion to introduce RS 29116. Motion carried by voice vote.

RS 29134: Rep. Troy presented RS 29134 which provides a designated process for absentee

ballot assistance to persons in nursing care facilities. Rep. Troy stated that Idaho's fast-growing aging population will see an increase of problems in ensuring a secure voter process for residents of care facilities and that additional support is needed in designating non-partisan, trained assistance to this demographic. Three authorized methods of support would be enacted: A volunteer trained in non-partisan assistance would be available through the County Clerk's office by request of the absentee voter or the resident's care facility; the County Clerk's office can request one volunteer from each recognized political party in Idaho to jointly meet with and assist the absentee voter, or an immediate family member

of the absentee voter can assist them.

In response to committee questions, **Rep. Troy** reiterated there would be minimal to no extra cost for this policy as the County Clerk's office already utilizes volunteers for election needs, and existing training syllabi provided to these volunteers can encompass providing non-partisan assistance to the elderly or other nursing care residents. In response to follow up questions, Rep. Troy explained that the County Clerk's office would be responsible for finding volunteers within the community.

Committee members commented with concern that the bill did not address how the process might be handled in instances where the absentee voter was having issues with memory loss or cognitive functioning, and they could envision potential conflicts of interest sending affiliated persons to help. **Rep. Troy** stated that while we can't legislate "bad behavior, " we should try to help in the ways that we can by offering non-partisan options, and this process would prevent direct partisan influence so the three established assistance options are in place as law and candidates, staffers, or other persons attempting to influence or direct the absentee voter towards a specific candidate would be facing misdemeanor charges.

Committee members commented that they wanted to make sure the definition of immediate family is established in the bill.

**MOTION:** Rep. Palmer made a motion to introduce RS 29134 without the Emergency Clause

verbiage.

**SUBSTITUTE MOTION:**Rep. Skaug made a substitute motion to introduce RS29134 with the following changes: to add Idaho Code Title 26 Ch. 31 page 303 line 4 (2631-303(4) to page 1, line 35 to define "Immediate Family." Substitute Motion carried by voice vote.

RS 29131: Rep. Troy presented RS 29131 which would standardize the deadline for any

unaffiliated voters to choose and register an affiliation by the candidate filing deadline. This would eliminate the ability to change to a different party or become unaffiliated instead of allowing changes any time up to and including the primary

election day. There is minimal to no cost associated with this change.

MOTION: Rep. Andrus made the motion to introduce RS 29131. Motion was carried by

voice vote.

Chairman Crane assigned Rep. Young and Rep. Mathias as proofreaders for

committee minutes and Sub-Committees were still to be determined.

RS 29127: Rep. Ehardt presented RS 29127. This legislation seeks to remember the lives of

unborn children who have perished as a result of abortion. The resolution would call for Idaho to lower the flag to half-staff annually on January 22 to honor the loss of over 62 million lives since the inception of Roe v. Wade. Rep. Ehardt noted the legislation was introduced nationally by **Rep. Mike Braun** from Indiana and that Idaho is joining Ohio, Mississippi, Tennessee, West Virginia, Oklahoma, and South Carolina as states introducing this resolution so far this year as well as Alabama,

Arkansas, and Louisiana last year.

**MOTION:** Rep. Furniss made a motion to introduce RS 29127 to the floor for reading.

SUBSTITUTE MOTION:

**Rep. Young** made a substitute motion to introduce **RS 29127** and recommend it be sent directly to the Second Reading Calendar. **Motion carried by voice vote.** 

Rep. Ehardt will sponsor the bill on the floor.

RS 29150: Rep. Lickley presented RS 29150 which seeks to show recognition of one of

Idaho's last centenarians of the "greatest generation," **Henry Fox LeMoyne**. Known by friends as Harry "the Fox" LeMoyne, he was a WW2 fighter pilot, a recipient of a Distinguished Purple Heart and the Flying Cross award. Mr. LeMoyne is widely known for his developments in agriculture and irrigation methods. He was inducted into the Southern Idaho Livestock Hall of Fame. His rich history of contributions to the State and people of Idaho also include his time spent as a County Assessor, an alumni of the University of Idaho and Boise Junior College, and his dedication to family and community. He passed away in August 2021, just shy of 103 years old.

MOTION: Rep. Furniss made a motion to introduce RS 29150 and recommend it be sent

directly to the Second Reading Calendar. Motion carried by voice vote. Rep.

Lickley will sponsor the bill on the floor.

**Chairman Crane** called the meeting to order at 9:00 a.m.

**MOTION:** Rep. Mathias made a motion to approve the minutes of the January 18, 2022

meeting. Motion carried by voice vote.

RS 29159: Rep. Nash presented RS 29159. This legislation was presented last session and

became **H 335** but never made it to vote. It seeks to address election integrity by ensuring all districts with 100,000 residents or more have candidate names rotated on ballots instead of a fixed order. This prevents the psychological preference known as "ballot order effect" voters may have towards a candidate who is listed on the top. The ballot order rotations were removed in small districts about ten years ago to save money but the exceptionally close outcomes in recent elections support larger districts renewing ballot order rotation to ensure fairness in the

selection process.

MOTION: Rep. Furniss made a motion to introduce RS 29159. Motion carried by voice

vote.

RS 29223: Rep. Scott presented RS 29223. This legislation was passed by the House in 2020

but was held in the Senate and is being re-introduced for the purpose of limiting aggressive taxation efforts by requiring a waiting period of 11 months after a bond vote before a district can hold a new vote about the same bond. In response to committee requests, Rep. Scott agreed that information on impact to taxpayers incurred during the 11 month waiting period due to the flux of interest rates could

be added to the bill prior to it receiving a full hearing.

MOTION: Rep. Hanks made a motion to introduce RS 29223. Motion carried by voice vote.

RS 29224: Rep. Scott presented RS 29224. This legislation seeks to guarantee consumers

making purchases subject to taxation in Idaho must be allowed to pay with cash. All people must be provided equal opportunity to pay with their choice of legal tender. Businesses refusing to allow cash purchases are technically discriminating against customers based on the individual's financial status. In response to committee discussion, Rep. Scott provided an example of how a constituent reached out to her when a business refused to accept a cash payment of \$10 for a mandatory drug screen and said the consumer must pay via credit or debit card. The consumer did not have a credit or debit card. When the business would not accept his cash, he was unable to comply with his Probation requirements within the time frame required and became at risk of having his Probation violated. In response to committee concerns the bill did not address setting minimum or maximum limits for cash transactions, Rep. Scott said there is no established limit because individual

must allow people to pay with cash. **MOTION:** Rep. Barbieri made a motion to introduce RS 29224. Motion carried by voice vote. Rep. Hanks presented RS 29267. It seeks to codify content from H 339 during last RS 29267: session to ensure state officials or offices cannot mandate the use of masks or face coverings to contain or inhibit the spread of diseases, contagious or otherwise. In response to committee questions, Rep. Hanks stated people need to use common sense and have autonomy over whether they wish to wear a mask or not regardless of the purpose for the mask. MOTION: Rep. Skaug made a motion to introduce RS 29267. Motion carried by voice vote. Idaho Code as related to the legal abortions performed in the state as it had not

been updated since approximately 1971.

MOTION: Rep. Scott made a motion to introduce RS 29214. Motion carried by voice vote.

RS 29264: Rep. Nate presented RS 29264 which would allow the Idaho State Treasurer to

use investment funds to obtain physical gold and silver reserves. This would allow enhanced ability by the Treasury to guarantee assets over current legislation.

MOTION: Rep. Hanks made a motion to introduce RS 29264.

In response to committee questions, **Rep. Nate** stated he wasn't aware whether there was a large demand for assets to be put into gold or silver and that additional

information about the monetary value and physical amount of Idaho's current silver

deposits could be included in the bill before its hearing.

VOTE ON MOTION:

Motion carried by voice vote.

The committee requested permission to re-open the discussion regarding **RS 29264**. During discussion, the specificity of language used in the bill was weighed. Committee members noted with concern decisions made to protect or preserve rights over one issue would have implications on many other issues and the limitations of personal freedoms stated in this bill could set a dangerous legal

precedent.

Committee members also discussed whether all legislation should be heard in committee regardless of opinion on the value of said legislature. **Chairman Crane** reminded members the governing purpose of a House Standing Committee was to evaluate the merit of a proposed piece of legislature therefore ideas not supported by any realistic standards would not be justified to come before the committee.

**Chairman Crane** called the meeting to order at 9:00 a.m.

RS 29346: Rep. Okuniewicz presented RS 29346 which would allow appropriate review to be

conducted before removal or relocation of historic monuments or memorials from state property. The Idaho Historical Society would need to approve the process prior to any state entity moving the monuments or re-naming memorials or historic

buildings.

MOTION: Rep. Palmer made a motion to introduce RS 29346. Motion carried by voice

vote

RS 29273: Rep. Skaug presented RS 29273 which would allow the Secretary of State or a

County Clerk to request judicial review in the event of a suspected election error where the error is sufficient enough in nature to affect the outcome of an election. Currently, there isn't any legal recourse for anyone other than a candidate in the election to seek review of said election. In response to committee questions, Rep. Skaug stated there had not been documented or reported evidence of "ballot stuffing" or other criminal activities surrounding elections in Idaho, but the possibility of clerical error or other human error occurring was a concern for which this

legislation would provide legal recourse.

MOTION: Rep. Monks made a motion to introduce RS 29273. Motion carried by voice vote.

DOCKET NO. 40-0000-2100:

**Michael Faison**, Executive Director for the Idaho Commission on the Arts presented **Docket No. 40-0000-2100**. He explained there were no real policy changes since last term but they had made significant efforts to reduce all redundancies or unnecessary verbiage. In a reduction of 80%, the agency rules now only consisted of 4 pages. In response to committee questions, Mr. Faison said the elimination of so much material made it possible for the Commission to more efficiently respond to funding requests but hadn't negatively affected their core purpose. For example, by removing language in a rule that required assistance be diverted through one organization, they were able to quickly and directly assist arts efforts in other arenas, such as funding Arts Therapy programming for the Veterans Association. In response to additional committee concerns about rules outlining funding limitations, Mr. Faison explained funding for "Red Carpet Events" are any kind of arts organization needing a singular donation for a specific reason, not an on-going bailout for that agency. Furthermore, while funding was not provided for any religious proselytizing purposes, it was provided for events or organizations

held in or by churches such as the Boise Boys' Choir.

MOTION: Rep. Skaug made a motion to approve Docket No. 40-0000-2100 in full. Motion

carried by voice vote.

DOCKET NO. 31-0000-2100:

**Eric Anderson**, President of the Idaho Public Utilities Commission (PUC) presented **Docket No. 31-0000-2100** and stated no changes had been made since last year.

DOCKET NO. 31-0101-2101:

Eric Anderson, President of the Idaho Public Utilities Commission (PUC) presented **Docket No. 31-0101-2101** which does have changes for review. He introduced **Stephen Goodson**, Policy Analyst for the PUC, who explained the changes primarily consisted of a reduction in redundancies and outdated references, i.e. writing on chalkboards, but some policy changes were adopted to allow electronic filing and conforming to the current demands of Green energy. In response to committee concerns about the decision to "Go Green" as it was not done with permission of consumers or legislative input, Mr. Anderson said the reality is Wall Street dictates the rules by not funding high carbon utilities anymore. Green energies are the options being funded and therefore the commission has to go this route. In response to committee questions about reports of issues with meters, Mr. Anderson recommended these concerns be directed to the PUC consumer assistance staff. As the issues are currently being addressed by other legal venues he would be remiss in discussing that topic. In response to additional committee questions, Mr. Anderson said he was not familiar with something called "ESG" and did not think that was under the purview of the PUC.

MOTION:

**Rep. Skaug** made a motion to approve **Docket No. 31-0000-2100**. **Motion carried by voice vote.** 

In continued discussion of the changes proposed in **Docket No. 31-0101-2101**, committee members considered several procedural changes that were proposed. The process related to testifying under oath in Rule 250 had been altered to exclude the traditional phrasing of "the testimony ... before the Commission is the truth, the whole truth, and nothing but the truth." Eric Anderson said the language had been updated but the process is still the same. He said the public hearing component is also unchanged in practice because companies who provide various services negotiate matters privately to make things happen. The public does not weigh in on these discussions nor have they ever. Rule 261 states "the Commission generally follows rules ..." and was discussed with concern. Mr. Anderson explained that there are times when numerous entities will present contradictory evidence or simultaneous objections during hearings and in these instances, the commission will approve the spirit of the thing if not the exact thing. Committee members agreed from a legal standpoint, the commission must have the autonomy to function this way to avoid creating the chaos of getting attorneys involved to argue each individual contradictory point that might be in contention during proceedings.

MOTION:

Rep. Gannon made a motion to approve Docket No. 31-0101-2101.

SUBSTITUTE MOTION:

**Rep. Hanks** made a substitute motion to approve **Docket No. 31-0101-2101** with the exception of Rule 250 which will be rejected as there was merit to the traditional language. **Substitute Motion carried by voice vote**.

**Chairman Crane** called the meeting to order at 9:00 a.m.

RS 29345: Rep. Moyle presented RS 29345 which would limit ballot handling to election

officials, U.S. Mail carriers, employees of nationwide parcel delivery businesses, and acknowledged family members. The limit of absentee ballots that an individual could convey to an election site on behalf of friends or family would be six (6) ballots only. There is concern that a process known as "ballot harvesting" might become a problem in Idaho and this legislation seeks to prevent it. If a person is being paid to transport ballots by anyone other than the voter or if the cumulative number of ballots being transported reached ten (10), the person would face a felony. Other

violations of the law would be a misdemeanor.

MOTION: Rep. Skaug made a motion to introduce RS 29345. Motion carried by voice vote.

RS 29360: Rep. Moyle presented RS 29360 which creates a comprehensive plan tying a

homeowner's tax exemption address to the address where a person will also be registered as a voter and where they are eligible to run for office. It also provides oversight ability to the Tax Commission and Secretary of State to make sure people

are not claiming multiple addresses for exemptions, voting, or candidacy.

MOTION: Rep. Young made a motion to introduce RS 29360. Motion carried by voice vote.

RS 29354: Rep. Moon presented RS 29354 which creates additional proof of identity

requirements for election integrity purposes. Proof of residency, proof of identity and proof of citizenship would all be required to vote in the state of Idaho. This proposed legislation would nullify affidavits and replace them with provisional ballots, and would require anyone not in possession of proper identity verification documents at the time of voting to vote using a provisional ballot. This would be secured in a separate location than verified identity ballots. The provisional voter would have a maximum ten (10) days post-election to return to the county clerk to provide photo identification and have their provisional ballot counted amongst regular ballots. In response to committee questions, Rep. Moon said this proposed process had not been vetted by city election officials, and provisional ballots would

be marked with the name of the voter for verification purposes.

**MOTION:** Rep. Hanks made a motion to introduce RS 29354.

The committee had additional questions before addressing the motion. There was concern why affidavits were being called into question and if Idaho specifically had reason to believe affidavits should not be trusted going forward. There was also concern about what types of identification were considered valid. **Rep. Moon** stated while Idaho had not experienced reported affidavit problems, Washington has had one confirmed situation where an affidavit was found to be a lie. In regards to the changes of what photo ID's would be accepted, a school-issued student ID would not be acceptable because it simply doesn't provide the information needed to verify identity, i.e. date of birth. It's also too easy to create a fake student ID. Students would have to acquire a non-driver's government issued photo ID via proper resources if they didn't have other government documents that met the criteria. A photo ID that would be allowed going forward at the polls would be a state issued concealed weapon permit as it contains all the information necessary to establish identity and residency.

VOTE ON MOTION:

Chairman Crane called for a vote on the motion to introduce RS 29354. Motion carried by voice vote.

H 521:

**Rep. Young** presented **H 521** which seeks to eliminate language used in Idaho Code § 18-608. The language in existence was taken directly from Roe v. Wade in 1973 and the reasons outlined as justifying abortions in the state of Idaho are not reflective of the current statutes. In response to committee questions, Rep. Young said regardless of Supreme Court decisions issued in 2015, and specifically regarding the section requiring 2nd trimester abortions be performed in a hospital being unconstitutional, the language was already in this section of Idaho Code and was not being considered for removal in **H 521**. There was also committee concern that language was being introduced to the code which might allow physicians performing abortions to be held liable for the loss of life and sued for performing an abortion. Rep. Young said the language was to ensure no one medical provider was influencing someone's decision to have an abortion.

**David Ripley**, Executive Director for Idaho Chooses Life, testified **in support** of the bill. He said similar legal attempts have been done in regards to Down Syndrome but the fact is, the language contained in this bill doesn't allow any changes to the legal circumstances allowing an abortion in Idaho. He wants everyone to be clear the legislation doesn't give permission on any scenario that makes abortion acceptable but allows the code to remove passages not embraced by the people of Idaho. **Blaine Conzatti**, President of Idaho Family Policy Center also testified **in support** of the bill. He stated removing the current language is a good first step towards aligning Idaho policy on abortions with how he sees residents feel. He said the language passed down from Roe v. Wade contained in Idaho law is superfluous and unneeded.

MOTION:

**Rep. Hanks** made a motion to send **H 521** to the floor with a **DO PASS** recommendation.

**Rep. Young** returned for committee questions. Committee concerns for **H 521** included the proposed legislation was already addressed in other bills, and the role of physicians as outlined limits their ability to offer medical recommendations without opening themselves up to additional repercussions. Additional concern was voiced about Idaho legislation stating abortion is murder but mothers and doctors are exempt from repercussions whereas this bill contains language stating certain types of abortions are lawful. Rep. Young reiterated the language about the role of the physician already exists in code and doesn't change anything in regards to the law. By adding the word "only" to specify "...abortions are... only lawful if performed in a hospital", the Idaho Code will be consistent with how the Idaho Law is written.

RS 29409: Rep. Crane presented RS 29409 which proposes the time frame allowed for

candidates to file intent to run for office should be shortened from two weeks to one week. The extra week has seemed to prove a distraction for candidates and slows

down legislative processing annually.

**MOTION:** Rep. Scott made a motion to introduce RS 29409 without the emergency clause.

In response to committee questions, **Rep. Crane** said the emergency clause shouldn't affect candidates seeking re-election because they would have already filed and their campaigning schedule needs to be planned around filing deadlines. In regards to which week would be removed to shorten the filing time table, he said

the end date for filing stays the same but the first week is removed.

**SUBSTITUTE** Rep. Monks made a substitute motion to introduce RS 29409 as it is written.

MOTION: Substitute motion carried by voice vote.

RS 29342: Rep. Ehardt presented RS 29342 which seeks to honor Idaho's National

Championship baseball team, the Bandits, who have won despite interruptions and

shut-downs caused by the COVID-19 pandemic.

**MOTION:** Rep. Scott made a motion to introduce RS 29342 and recommend it be sent

directly to the Second Reading Calendar. Motion carried by voice vote. Rep.

**Ehardt** will sponsor the bill on the floor.

RS 29379: Rep. Monks presented RS 29379 which would allow the use of public property

by a political party or group for an event where the space is used in accordance with its limitations and equal access is allowed for candidates or parties regardless

of political affiliations.

MOTION: Rep. Skaug made a motion to introduce RS 29379. Motion carried by voice vote.

H 511: Rep. Nash presented H 511 which seeks to ensure election integrity by rotating

candidate names on ballots for all elections where the population is 100,000 or more. This is to avoid "ballot order effect," a psychological phenomenon which gives voter preference to the name listed at the top of the ballot. Anywhere from 3-7% of the total vote can be affected by ballot order especially where there is a tendency to have "low information" elections. The Secretary of State and County Clerk's offices have been consulted on this legislation and raised no expected

difficulties or concerns to enact this procedure.

In response to committee questions, **Rep. Nash** explained current election ballot order is decided by county clerks choosing a randomized alphabet and then candidate names are listed in fixed order accordingly. County clerks were the ones who established voter populations of at least 100,000 as having the most impact on election outcomes. There are several elections affecting populations of 100,000 or more across the state so it's not just one or two geographical areas.

MOTION: Rep. Mathias made a motion to send H 511 to the floor with a DO PASS

recommendation. Motion carried by voice vote. Rep. Nash will sponsor the bill

on the floor.

**MOTION:** Rep. Scott made a motion to postpone presenting H 512 as additional information

needed was still incoming. Motion carried by voice vote.

**DOCKET NO. Jason Hancock**, Deputy Secretary of State presented **Docket No. 34-0000-2100**.

**34-0000-2100:** No changes have been made since last year.

**DOCKET NO. Jason Hancock**, Deputy Secretary of State presented **Docket No. 34-0000-2100F**. The notable changes consist of most fees being condensed and simplified with only

one change that would increase the cost to consumers. In response to committee requests for specific examples, Mr. Hancock explained consumers would now be able to pay one fee of \$60 and access as many product lists as they wanted during that transaction instead of a \$30 access fee and another \$30 for each product list.

**Mr. Hancock** introduced **Cathy Abbott**, the Finance Director for the office of Secretary of State who explained the one fee increase. Consumers could now access all desired documents online as a bi-weekly download for \$125 each time

instead of a \$125 fee for delivery of printed copies once a month.

**Chairman Crane** called the meeting to order at 9:01 a.m.

H 531: Rep. Okuniewicz presented H 531 which seeks to provide safeguards against

any attempt to delete U.S. history by stipulating the Idaho Historical Society must review and approve any significant moderation or removal of a historical monument or memorial. It would not include any temporary alterations for repair, nor would it mean a memorial or monument could not be relocated to a similarly zoned location. It would apply only to permanent removal or re-naming, and for permanent relocation of an historical memorial or monument to a less visible location than its original one. In response to committee questions, Rep. Okuniewicz explained the Idaho Historical Society board members are appointed by the Governor, and their governing decisions are based on a two-thirds majority vote requirement. The two-thirds vote was chosen instead of simple majority vote due to the permanent

outcome of decisions made by the board.

**MOTION:** Rep. Skaug made a motion to send H 531 to the floor with a DO PASS

recommendation. Motion carried by voice vote. Rep. Okuniewicz will sponsor

the bill on the floor.

H 514: Rep. Hanks presented H 514 which seeks to remove any mask mandate issued

by state government entities.

Those speaking **in support** of **H 514** were **Dr. Lynn Laird**, a practicing psychologist in Meridian, Idaho and **Lorna Mitson**, citizen. Dr. Laird said she is seeing daily evidence the normal social development of children across all ages is being negatively impacted by not being able to see people's faces and expressions. Ms. Mitson testified the mask mandates have been divisive and harmful. The exemptions granted have been inconsistent and people are being harassed and abused when they aren't wearing a mask regardless of the reason. Her daughter is experiencing isolation at her university and mask mandates are negatively impacting her ability to find a job.

Speaking **in opposition** to **H 514** was **Stephanie Mickelsen** from Mickelsen Farms. She said this bill would prohibit local government from enacting laws based on the needs of their area and it would additionally prohibit people from protecting themselves in the event of future epidemics that could be worse than COVID-19.

**Rep. Hanks** was called upon for closing remarks and committee questions. The need for children's proper development outweighs the need for government mandates at this time. She re-iterated this legislation does not prohibit anyone from wearing a mask. If people were experiencing life threatening symptoms en masse that masks could prevent, they would wear masks but this has not been what Idaho is experiencing. Everyone is responsible for their own health and should have the freedom to make decisions accordingly. There were no stipulated consequences addressed in this bill if it were to be enacted and not followed by state entities.

MOTION: Rep. Barbieri made a motion to send H 514 to the floor with a DO PASS

recommendation. **Motion carried by voice vote**. **Rep. Hanks** will sponsor the bill on the floor. **Reps. Gannon** and **Mathias** requested to be recorded as voting **NAY**.

RS 29450: Rep. Young presented RS 29450 which seeks to enact legislation that builds

on the principles already in law. It specifies when a person requests a religious exemption from a medical treatment or process, it must be honored and respected

consistent with the standard expected of all religious freedoms.

MOTION: Rep. Scott made a motion to introduce RS 29450. Motion carried by voice vote.

DOCKET NO. Steven Bai 38-0000-2100: presented I

**Steven Bailey**, Deputy Director of the Idaho Department of Administration (IDA) presented **Docket No. 38-0000-2100**, which establishes how the interior and exterior of state property is managed, use of the Chinden office complex, and rules concerning the division of purchasing. No changes have been introduced from the previous year. In response to extensive committee questions about the current protests taking place at the old courthouse complex next to the State Capitol building, Mr. Bailey stated the protestors are in compliance with the rules set forth by the IDA. They are working closely with Idaho State Police to monitor continued compliance. There are no rules stipulating how long protests may be held, only the matter in which they are conducted. He clarified while camping would be a violation of the rules, the protestors were not camping; the tents in place are symbols to provide visual demonstration. He also stated to the best of his knowledge, there were not signs posted on state properties prohibiting weapons on the premises.

**Keith Reynolds**, Director of the Idaho Department of Administration (IDA) was introduced by **Mr. Bailey** to address additional committee questions. Mr. Reynolds stated there were defined guidelines in place on what methods or materials can be used in demonstrations or protests although not every possible imagined scenario was stipulated. Animals nor vehicles are allowed on state grounds for purposes of demonstrations and there are guidelines protestors must adhere to so as not to disrupt business of the State or neighboring private businesses. He stated the goal of the IDA is to ensure best efforts are made to address situations as they arise to ensure the people are safe, the buildings are safe, free speech is protected and honored, and to remain free from intimidating the people.

MOTION: Rep. Skaug made a motion to approve Docket No. 30-0000-2100. Motion

carried by voice vote.

**DOCKET NO. Steven Bailey**, Deputy Director of the Idaho Department of Administration **38-0000-2100F**: presented **Docket No. 38-0000-2100F** which are the rules stipulating the fe

**Rep. Palmer** called the meeting to order at 9:01 a.m.

RS 29426: Rep. Monks presented RS 29426 which seeks to codify and expand Executive

Order 2021-04 issued by **Governor Brad Little** on April 7, 2021. Individuals will not be required to provide proof of vaccination or immunizations or negative test results in order to apply for or receive services provided by the state of Idaho, enter a government venue, or to be hired or maintain employment with the state with some exceptions. State employees whose job requires travel to areas where vaccines are required by law will be required to obtain the vaccines applicable by law to those areas. Schools have their own sub-section of requirements. This legislation does not deal with requirements issued by private sectors. In response to committee questions, Rep. Monks said he didn't know whether the verbiage specifying vaccinations for communicable diseases meant that there were vaccines

required or even offered for non-communicable diseases.

MOTION: Rep. Crane made a motion to introduce RS 29426. Motion carried by voice vote.

Rep. Palmer announced H 532 would be removed from today's agenda at the

request of the sponsor.

**H 567:** Rep. Crane presented H 567 which would decrease the period of filing for a

candidate wishing to run for election from two weeks to one week, stating there has been a trend by incumbents seeking re-election to delay dealing with large issues in legislation during election years. In response to committee questions, Rep. Crane stated that incumbents have shown the tendency to become obsessed with what everyone else is doing during those two weeks and vying for position or withholding ideas. The legislation gets held up and delayed due to political tactics

and it shouldn't be that way.

In opposition to H 567 Hollie Conde, representing the Conservation Voters of Idaho (CVI) stated the process of running for office is a difficult and stressful one. In order to keep things fair for people who are not already political insiders, shortening the filing period will only increase the steep learning curve and stress for the average person trying to run for office. This process should not be even more stressful or allow processes that will likely discourage new people to get involved in local politics. In response to committee questions, Ms. Conde stated CVI is a non-partisan organization whose goal is to support candidates whose focus is on

championing the environment and conservation efforts.

**Rep. Crane** returned to respond to additional committee questions. He stated he believes new candidates will not have issues filing their intent to run within a one week time frame any differently than a two week time frame but it will force incumbents to focus on the job at hand. Concerns issued by committee members included examples of new candidates needing longer than one week to correct paperwork issues found only once the intent to run is reviewed by the Secretary of State's office or County Clerk, such as needing additional signatures in order to meet the required filing criteria. In the case of incumbents, even ensuring adequate child care to allow the official to carry out the duties of an elected office could require more than one week to set up and their decision to seek re-election is dependent on resolving these family or other work obligations.

MOTION:

**Rep. Monks** made a motion to send **H 567** to the floor with a **DO PASS** recommendation.

Discussion on the motion was held. Committee members expressed concern for enacting the legislation with the emergency clause attached because it would interfere with the current intent to run filing period.

SUBSTITUTE MOTION:

**Rep. Skaug** made a substitute motion to send **H 567** to the floor and strike the emergency clause.

AMENDED SUBSTITUTE MOTION: Rep. Scott made an amended substitute motion to send H 567 to General Orders to remove the emergency clause. Amended substitute motion carried by voice vote. Reps. Gannon and Mathias requested to be recorded as voting NAY. Rep. Crane will sponsor the bill on the floor.

**Rep. Crane** announced **H 439** was removed from the agenda at the request of the sponsor.

**Rep. Mathias** announced he had an answer to the committee's earlier question about whether vaccinations were available for non-communicable diseases as the verbiage used in **RS 29426** suggested there could be. He explained the verbiage about vaccinations or immunizations for communicable diseases was used to clarify the state's position was of concern only for diseases that were communicable and therefore affecting the population at large, not whether there were other types of vaccines.

**ADJOURN:** 

There being no further business to come before the committee, the meeting adjourned at 9:24 a.m.

**Chairman Crane** called the meeting to order at 9:00 a.m.

RS 29016C1: Rep. Monks presented RS 29016C1 which seeks to extend Idaho's participation in

the multi-state lottery game Powerball as well as including participation by Australia and the United Kingdom. Powerball has been in Idaho for several decades and this legislation would allow continued participation. Rep. Monks stated he was not an advocate of gambling but of fair business practices. He supported the continuation of Powerball due to the fact the lottery would still exist in Idaho without it but the

remaining entity would have a monopoly on lottery commissions.

**MOTION:** Rep. Palmer made a motion to introduce RS 29016C1.

Discussion on the motion was held. Committee members expressed concern at the idea of state sponsored gambling or state funds being used to advertise gambling. It was clarified the House is able to stipulate what would and would not be allowed by Powerball, or lottery advertising in general by the Idaho Lottery Commission, via floor discussion and vote. The issue of creating legislation that ultimately procured an international business deal was mentioned as being at odds with the core values of "the state minding state business" held by the Majority party.

**Rep. Monks** stated Powerball was already an international game as Idaho's participation has been contracted alongside Canada. Idaho's continued participation would be a contract with the Multi-State Lottery Commission, not foreign countries. In response to additional committee questions, Rep. Monks said the delay last year in enacting the legislation was due to labor contract disputes between the Powerball vendors. The legislation stalled while those issues were pending but Idaho does have to make a decision at this time to continue participation or opt out of allowing Powerball to remain in Idaho.

VOTE ON Chairman Crane called for a vote on the motion to introduce RS 29016C1. Motion

MOTION: carried by voice vote.

H 522:

**Rep. Nate** presented **H 522** which would allow the State Treasurer of Idaho to utilize gold and silver as an additional method of investment. The State Treasurer is responsible for keeping funds afloat and faces the same challenges held by individuals in adjusting for inflation and accommodating financial needs accordingly. The funds the State Treasury has have decreased in face value and could pose a risk to guaranteed funds for citizens when dealing with federal obligations. By allowing the State Treasurer to invest in gold and silver and maintain physical stores of precious metals, inflation risk can be mitigated. In response to committee questions, Rep. Nate said Idaho would not be the first state to invest in or maintain gold and silver. Additionally, Ohio and Texas allow retirement funds to be invested in gold and silver.

**Bob Coleman** spoke **in support** of **H 522**. He is a registered investment advisor who runs one of the largest private precious metal depositories in the United States located in Nampa, ID. He stated gold and silver are widely used for investments and it's a competitive area of investment as well. From a long term perspective, he believes it would be beneficial for Idaho to have the option to utilize gold and silver in their State Treasury. In response to committee questions about the costs associated with building and maintaining storage to house precious metals, he said the proceeds from gold investments have consistently outweighed the costs of storage and show an average of 30% return.

MOTION:

**Rep. Hanks** made a motion to send **H 522** to the floor with a **DO PASS** recommendation. **Motion carried by voice vote**. **Rep. Nate** will sponsor the bill on the floor.

H 512:

**Rep. Scott** presented **H 512** which is designed to limit repeat bond elections in aggressive taxing districts. By limiting a bond to only run every 11 months, the same bond cannot be presented over and over during the year. When a community is in need of something that will cost them money, the people asking for the money need to construct these requests carefully and with due diligence.

Those speaking **in opposition** to **H 512** were **Quinn Perry**, Deputy Director for the Idaho School Board and Idaho Board of School Administrators; **Craig Woods**, Superintendent of Emmett School District, **Alicia Abbot**, representing the Idaho 97; **Jeff Dillon**, Superintendent of Wilder School District; and **Aaron Johnson**, representing the Idaho construction industry and general contractors in the Idaho Falls area. They were of the opinion that **H 512** would severely impede the ability of communities throughout Idaho to obtain the funds needed to adequately address the state's booming population, especially in public schools. During the 11 month wait, the dramatic inflation being experienced across the United States could render communities helpless in their ability to fund not only the costs of the project proposed in the bond but the increase of costs incurred during the wait. It might well prove impossible to get any project done on budget or in a timely manner.

Those speaking in support of H 512 were Michael Law, citizen; Halli Stone, citizen; and Brian Stutzman, citizen. They were of the opinion that many people are struggling to shoulder the costs of not only paying for the funds generated by a bond but also paying the cost for the bond election as well. When a district runs a bond election over and over, it feels like they're just trying to wear people down to get it passed even when an area doesn't want what is being proposed. They feel no one would be hurt by imposing a wait period except the people trying to take advantage of others.

**Chairman Crane** put the committee at ease at 9:49 a.m. due to technical issues with the remote testimony equipment.

**Chairman Crane** resumed the meeting at 9:56 a.m.

**Rep. Scott** returned for committee questions. She stated the estimated cost of running a bond election vote is fifteen (15) dollars per ballot which means bond elections could cost a community \$5,000 or \$30,000 or more. It's common practice across the United States for bond elections to have time frame limitations. A waiting period of 11 months means taxpayer dollars won't be wasted on careless bonds. She clarified the bill would not prevent non-related bonds from running as needed, just that the same bond could not be run over and over. She also clarified the bill is not targeting schools, but aggressive taxing districts. If schools are meeting that criteria then additional work is needed to address the needs of the schools separately from this legislation.

**MOTION:** 

**Rep.** Hanks made a motion to send **H 512** to the floor with a **DO PASS** recommendation.

Committee members discussed the motion. Committee members voiced concern about the ability of local governments being restricted from addressing issues in a timely manner or staying on budget for these issues. The requirements of a super majority approval, or two-thirds majority, to pass a bond vote makes it unique from other types of votes. When a mere single digit percentage variance can dictate the outcome, it's not unreasonable to think 11 months would be far too long to address and correct the community concerns needed to get the bond passed. This is especially true in Idaho where voter turnout for any election is consistently an extremely low percentage of the population.

ROLL CALL VOTE:

Rep. Scott requested a roll call vote. Motion carried by a vote of 10 AYE, 3 NAY, 1 ABSENT/EXCUSED. Voting in favor of the motion: Reps. Crane, Palmer, Barbieri, Holtzclaw, Monks, Scott, Andrus, Young, Hanks, and Skaug. Voting in opposition to the motion: Reps. Furniss, Gannon, and Mathias. Rep. Armstrong was absent/excused. Rep. Scott will sponsor the bill on the floor.

H 566:

**Rep. Monks** presented **H 566** which would allow equitable use of public areas for all recognized political parties wanting to have an event that is in accordance with the function of the location. These events have taken place on occasion as it was assumed they were allowed to do so but it would be prudent to get permissions in writing.

MOTION:

**Rep. Palmer** made a motion to send **H 566** to the floor with a **DO PASS** recommendation. **Motion carried by voice vote**. **Rep. Monks** will sponsor the bill on the floor.

**Chairman Crane** called the meeting to order at 9:01 a.m.

H 547: Rep. Moyle presented H 547 which seeks to address the prevention of a potential

election integrity issue known as ballot harvesting. The legislation stipulates only authorized persons may handle, convey, or transport absentee ballots from the

voter to the election office.

Speaking in opposition to H 547 were Kendal Shaber, League of Women Voters of Idaho; Shiva Rajbhandari, representing BABE Vote; and Hollie Conde,

Conservation Voters for Idaho. They were of the opinion **H 547** was a bill searching for a problem Idaho doesn't face. By disallowing individuals to help one another vote by absentee ballot, the bill would in effect be suppressing voters. There was also concern for use of the term "convey" in the bill. The assumption is the bill means the physical transportation of ballots but "convey" could also mean communication and clarity is needed. This bill would have unintended consequences that make it

harder for people to exercise their right to vote.

Speaking **in support** of **H 547** was **Jason Hancock**, Deputy Secretary of State. He stated that by its very nature, an absentee ballot is the least secure method of voting. Taking extra steps to limit undue influence on election outcomes by setting requirements on how absentee ballots were handled was a reasonable course of action. Ballot harvesting encourages people to be partisan actors and proceed

with bad motives.

MOTION: Rep. Palmer made a motion to send H 547 to the floor with a DO PASS

recommendation.

Committee discussion on the motion was held. Committee members said they were concerned about why the state is spending time trying to pass legislation making something Idaho doesn't even deal with an illegal action. Committee members also expressed there is a big difference between ballot harvesting and helping your neighbor or in-laws get their absentee ballot to the Elections office. The committee did clarify the legislation does not inhibit anyone from finding a trusted person to bring their vote to the polls but it would address a problem other

states are struggling to prevent.

VOTE ON MOTION:

Chairman Crane called for a vote on the motion to send H 547 to the floor with a DO PASS recommendation. Motion carried by voice vote. Reps. Gannon and Mathias requested to be recorded as voting NAY. Rep. Moyle will sponsor

the bill on the floor.

RS 29502:

**Rep. Nichols** presented **RS 29502** which seeks to ensure no person can be denied medical services due to their refusal of COVID-19 therapies or testing. She stated people have been denied medical services, including life-saving treatments, because of their COVID-19 status. In response to committee questions, Rep. Nichols said while the federal statutes do specify someone may not be denied medical services, there are gaps in the Idaho state code. There was not any language in **RS 29502** that would contradict federal law. Regardless of crisis of care standard enactments, this legislation would require patients refusing vaccinations must be able to receive medical care for medical issues. This legislation specifically addresses a patient's right to refuse COVID therapies and not medications or therapies in general.

MOTION:

Rep. Scott made a motion to introduce RS 29502. Motion carried by voice vote.

RS 29549:

**Rep. Hanks** presented **RS 29549** which would prohibit any state entity from issuing a mask mandate for COVID-19. This proposed legislation replaces the previously proposed **H 514**. Changes were made to clarify state employees who are required to wear masks or other breathing apparatus due to dangerous chemicals or inhalants still need to wear those protective devices. Additionally, the repercussions to a state entity stipulated in **H 514** were removed in **RS 29549**. This legislation focuses on giving people the choice to wear masks or other facial coverings for protection of a contagion.

MOTION:

**Rep. Scott** made a motion to introduce **RS 29549** and recommend it be sent directly to the Second Reading Calendar.

During discussion on the motion, committee members questioned why the state could not mandate clear face shields in lieu of masks as these would accomplish the overall goal of people being able to see one another's faces while still offering contagion prevention. It was also questioned whether someone could be asked or recommended to wear a mask, especially if they were known to have COVID-19 but were still out in public. Committee members were concerned how this legislation would affect the idea of local choice and local control. In response, **Rep. Hanks** said people can wear whatever kind of face covering they wanted, and certainly someone could be asked to wear a mask but any mandated requirement removes people's ability to choose how to manage their own health and well-being.

VOTE ON MOTION:

Chairman Crane called for a vote on the motion to introduce RS 29549 and recommend it be sent directly to the Second Reading Calendar. Motion carried by voice vote. Reps. Gannon and Mathias requested to be recorded as voting NAY. Rep. Hanks will sponsor the bill on the floor.

H 548:

**Rep. Moyle** presented **H 548** which seeks to create legislation to tie one eligible location to a homeowner's exemption, voter registration, and where someone is able to run for public office. It also provides the county tax assessor the ability to verify there is only one vote per one homeowner's exemption. He stated owning multiple properties is fine but someone can't legally reside in and vote at all of them.

**MOTION:** 

**Rep. Mathias** made a motion to send **H 548** to the floor with a **DO PASS** recommendation. **Motion carried by voice vote**. **Rep. Scott** requested to be recorded as voting **NAY**. **Rep. Moyle** will sponsor the bill on the floor.

RS 29506:

**Rep. Chaney** presented **RS 29506** which seeks to provide legal confidentiality for providers involved with all aspects of carrying out the death penalty in Idaho. This would include physicians and other licensed entities who provide, store, or transport the controlled substances and other materials required for enactment of lethal injection. Opponents of the death penalty have been making efforts to publicly denounce and inhibit functioning of any entities involved in carrying out lethal injections which has led to no one being willing to carry out these duties. He concluded if Idaho wants to have the ability to enforce the death penalty, the state needs to make legal protections for the enforcement of it.

In discussion of the proposed legislation, committee members requested three specific changes. On page 2, line 1, section a; remove the "s" from the word "physicians" to make it "physician" singular. On page 2, line 4, section b; add the word "stores" after the word "manufactures." On page 5, line 47, section 20; change the word "would" to "could."

**MOTION:** 

**Rep. Skaug** made a motion to introduce **RS 29506** with the specified corrections. **Motion carried by voice vote.** 

H 439:

**Rep. Okuniewicz** presented **H 439** which seeks to adjust the deadline for an unaffiliated voter wishing to become an affiliated voter to be the same deadline already established for all other types of voters. Currently unaffiliated voters can change or declare an affiliation any time up to and including Election Day.

Speaking in opposition to H 439 was Shiva Rajbhandari, representing BABE Vote; Hollie Conde for Conservation Voters of Idaho; and Alicia Abbott, representing The Idaho 97. They were of the opinion this bill would have a negative impact on Idaho voters. Voters generally try to align themselves with a candidate who best represents the same beliefs and concerns they do. There are some 310,000 unaffiliated Idahoan voters who would not have time to learn anything about a candidate, even their options of who the candidates are, if they are required to make a choice on who to support on the same day candidates must be done filing their intent to run for office. Idaho consistently sees many new candidates filing on the last day up to the last hour. This year specifically would especially have negative impact to voters; if enacted with the emergency clause, this legislation would inhibit those 310,000 voters from voting in the primaries in 2022.

During discussion of **H 439**, committee members discussed why setting a deadline to affiliate at all would prove beneficial and why there was concern should they not do so. They discussed possible benefits or drawbacks for someone to be an affiliated or unaffiliated voter. **Rep. Okuniewicz** stated the goal of this bill was to make the deadline equal for everyone and prevent "flip-floppers." He recognizes most unaffiliated voters are not playing games in any way, but there have been times when an unaffiliated voter deliberately registered with one party or the other for the purpose of sabotaging a primary election. Once the primary election was over, the voter became unaffiliated again. The committee questioned whether these attempts were a significant enough occurrence to influence an election outcome.

Jason Hancock, Deputy Secretary of State, was introduced to share official statistics for consideration of the committee. He stated Idaho has just shy of a million registered voters. Of these, Republicans make up just over half, Democrats are slightly less than one-third, and most of the remaining voters are unaffiliated. The number of registered Libertarian and Constitution Party affiliates is very small. Unaffiliated voters do have a significant impact on election outcomes overall. In 2022, the window to register or change an affiliation electronically will open for three days in March before the candidate filing deadline. Mr. Hancock did not know the specific number of people who historically have changed affiliation before an election primary and again after the primary but this number would be discoverable on the Secretary of State's website.

Committee discussion continued about whether allowing the deadline for unaffiliated people to choose an affiliation should extend for an additional time so people would have the opportunity to vet the candidates before a primary election. Committee members appreciated keeping the deadline consistent for all voters but were wary about hindering people from making informed decisions. They were concerned whether a few people with bad motives were making much of a difference versus holding everyone to the same deadline. **Chairman Crane** stated this bill specifically relates to primary elections, not general elections. Each recognized political party has the responsibility of choosing a candidate to represent their party and deserves to select the candidate they want speaking for them, not someone sabotaging them. The goal for a primary election is not necessarily the same as for a general election.

MOTION:

**Rep. Skaug** made a motion to send **H 439** to the floor with a **DO PASS** recommendation. **Motion carried by voice vote**. **Reps. Gannon** and **Mathias** requested they be recorded as voting **NAY**. **Rep. Okuniewicz** will sponsor the bill on the floor.

**MOTION:** Rep. Monks made a motion to postpone presentation of H 604 as additional

information needed was still incoming. Motion carried by voice vote.

RS 29470C1: Rep. Chaney presented RS 29470C1. This legislation proposes community

college board trustees would be selected and voted in based on established geographical zones. People can currently vote at-large for trustees which leads to a large population weighing in on leadership for areas where they don't live or pay taxes. It would become effective in two (2) years. The geographic boundary zones have already been redrawn and established across Idaho. In response to committee questions, Rep. Chaney stated this legislation would not address issues related to filling vacated school board seats mid-term, and the at-large voting process has been kept in the past due to general unease about not being able to

fill these positions.

**MOTION:** Rep. Andrus made a motion to introduce RS 29470C1.

In response to additional committee questions about newer legislation under consideration affecting school board elections, **Rep. Chaney** said there were mixed references to community colleges and other educational institutions so it wasn't feasible at this time to stipulate the differences pertaining to each individual type

of school board that could be affected in the future.

VOTE ON MOTION:

Chairman Crane called for a vote on the motion to introduce RS 29470C1. Motion

carried by voice vote.

RS 29524: Rep. McCrostie presented RS 29524 which would provide updates to legislation

concerning the products produced and sold by home brewers. It would allow the inclusion of mead, cider, and other fermented beverages to be made by home brewers in addition to beer and wine. It would also allow non-sale taste testing of these items as well as the storage and transportation of these beverages. In response to committee questions, Rep. McCrostie said the proposed legislation did include a technical correction to the current legislation clarifying both the manufacturing of wine and brewing of beer was allowed for home brewers.

MOTION: Rep. Scott made a motion to introduce RS 29524. Motion carried by voice vote.

RS 29563: Rep. Nichols presented RS 29563 which seeks to add a section to Idaho Code stating artificial intelligence, inanimate objects, environmental elements, and animals may not be granted personhood status in the state of Idaho. By getting this statute in Code, Idaho would preemptively address the growing trend across the U.S. where objects have been granted the same rights as people. In response to committee questions, Rep. Nichols stated this legislation would not affect anyone's ability to will their estate to a pet. Saudi Arabia's 2017 decision to grant citizenship to a robot or other similar honorary measures in title would not affect or correlate to this proposed legislation. MOTION: Rep. Barbieri made a motion to introduce RS 29563. Motion carried by voice vote. **Chairman Crane** called the meeting to order at 9:00 a.m.

RS 29562: Rep. Giddings presented RS 29562 which seeks to adopt state legislation in

accordance with federal legislation requiring voter registration lists be maintained, updated in a timely manner, and available to the public for the purpose of ensuring accuracy of eligible voters. In August 2021, a resident of Nez Pearce County requested a voter registration list from the Secretary of State's office. A letter of denial was issued by the Department of Health and Welfare (DHW) citing the reason for denial was because the list is considered a vital statistic and therefore not available to the public. In December 2021, another denial for the voter registration list was issued by the DHW pursuant to the advice of the Attorney General. The National Death Index has not had records for Idaho since 2019. In 2022, a deceased resident of Latah County was found named on the county's active voter rolls. On February 1, 2022, a formal request was issued to the Latah County Clerk to have the deceased person's name removed from their list of active voters but as of today's hearing, the request has not been addressed. **RS 29562** states Idaho must comply in the required process to remove deceased persons from the

RS 29594: Rep. Chaney presented RS 29594 which seeks to provide confidentiality and

H 607:

**Rep. Monks** presented **H 607** which seeks to continue Idaho's participation in the lottery game, Powerball. Powerball participation already includes Canada and the new agreement would include Australia and the United Kingdom. The proceeds go towards funding public education. He is advocating for Idaho's continued participation in the Powerball game as it provides significant financial benefits to Idaho schools and businesses. In response to committee questions, Rep. Monks said the monetary amount provided to Idaho's public schools from proceeds averages fifteen (15) million dollars annually. The secondary fiducial impact is mostly to small businesses, especially those who are located close to Idaho's state borders. Border businesses would in particular face the potential loss of a large revenue stream in secondary purchases like snacks, beverages, fuel, etc. if Powerball tickets were no longer available at their locations.

Jeffrey Anderson, Director of the Idaho State Lottery Commission was introduced for committee questions. He explained the functions of the Multi-State Lottery Association and the contract process for participating entities. He said the contract was technically a Letter of Agreement (LOA) and it is an at-will participation agreement. Idaho would be allowed to cease participation in the Powerball game if established codes of conduct were disobeyed by Powerball entities. The LOA is scheduled for the Idaho Lottery Commission board vote in March 2022. He further established the Multi-State Lottery Association is a non-profit organization. The MegaMillions Lottery Association is a for-profit organization. Intralot, Inc. is the company Idaho contracts with for scratch-off lottery tickets and they are an international company.

Speaking in opposition to H 607 was Jonathan Krutz, representing Idaho's Stop Predatory Gambling (SPG) organization. He stated Powerball puts a burden on small businesses by diverting funds away from hard goods and services into gambling. The business model of the lottery is to encourage people to spend money they may not have on gambling. In response to committee questions, Mr. Krutz stated his organization does not have the funds to assist people addicted to gambling and Idaho overall has very few resources for people struggling with a gambling addiction. He stated he felt the benefits of not having Powerball outweigh any losses incurred by choosing not to participate. He said people would spend their money on other taxable goods like major appliances if they weren't buying lottery tickets. The additional sales tax generated would make up for the loss of proceeds to public schools. He stated since these taxes go to the government, it was government's responsibility to fund the schools without resorting to sponsored gambling.

Speaking **in support** of **H 607** were **Charlie Jones**, owner of the Stinker convenient store chain; **Misty Swanson**, Executive Director of the Idaho School Boards Association; and **Matt Berry**, a fuel distributor in Eastern Idaho. They were of the opinion Powerball was a significant factor in Idaho's overall financial well-being.

**Mr. Jones** testified the Stinker stores were the first retailer to sell lottery tickets in Idaho and they are the state's third largest lottery retailer. Powerball specifically is different from the other types of lottery games in Idaho. Mr. Jones stated he does not believe Powerball customers would switch to purchasing scratch off tickets if Powerball was taken away because they are drawn to the idea of the "Big Jackpot" payout. The customers who buy state lottery tickets almost always buy other things from the stores. Stinker sees their revenue go up significantly when the Powerball payout is large; more customers than usual stop in to buy a ticket and then buy other items of necessity or convenience. Stinker is proud to be helping Idaho schools and wants to be able to keep doing so.

**Ms. Swanson** testified Idaho schools rely heavily on proceeds from Powerball to make vital upgrades and pay for on-going maintenance. If they lose this funding source, they would have to rely solely on bond votes passing. She said it's estimated Idaho public schools need close to a billion dollars to fully address the community needs at this time. That number is only going to get bigger with time as Idaho's population continues to grow.

**Rep. Armstrong** declared Rule 80 as she is a member of a school board. **Chairman Crane** also declared Rule 80.

In response to committee questions, **Ms. Swanson** stated there was no real backup plan to ensure Idaho public schools would receive the funds elsewhere required to keep operating safely. At this time, the funds simply don't exist without Powerball proceeds.

**Mr. Berry** testified the Idaho businesses that would likely face the biggest impact should Powerball be discontinued are the "mom and pop" stores he services in state border areas. Traffic and revenue would likely be diverted to the next closest retailer across state lines for fuel and other items of convenience because people are not inclined to make two separate stops. Since these stores face such narrow profit margins even with Powerball, the likelihood many of them could stay open without it is slim.

**Rep. Monks** returned for closing comments on **H 607**. He stated Powerball is a voluntary tax which people can choose to pay by participating in the game. Whether it's moral or not to gamble made little difference in how this legislation should be addressed. He chooses not to spend personal funds gambling or drinking alcohol but lottery and liquor tax is good business for the state. Committee members voiced concern about how Idaho could afford to fund public schools out of the overall state budget but chooses not to. They expressed frustration at being put in the situation of approving a program they don't particularly like in order to ensure children are being safely educated. They expressed additional concern over Idaho participating in what seems to essentially be an international trade agreement.

MOTION:

**Rep. Mathias** made a motion to send **H 607** to the floor with a **DO PASS** recommendation.

SUBSTITUTE MOTION:

**Rep. Skaug** made a substitute motion to **HOLD H 607** for time certain, March 7, 2022.

The committee discussed the substitute motion. Members agreed they felt it prudent to review the Letter of Agreement (LOA) between the Idaho State Lottery Commission and the Multi-State Lottery Association before deciding whether the bill should pass or not. The committee asked if Powerball could remain in Idaho if the state does not agree with international participation. **Rep. Monks** said no; Idaho does not get to decide who else participates, only whether they want to participate or not.

AMENDED SUBSTITUTE MOTION:

**Rep. Furniss** made an amended substitute motion to send **H 607** to the floor without recommendation. **Amended substitute motion carried by voice vote. Rep. Monks** will sponsor the bill on the floor.

RS 29587:

**Rep. Dixon** presented **RS 29587** which seeks to create new legislation governing Idaho's energy code by adopting the statutes set forth in the 2018 International Energy Conservation Code. The Idaho Energy Conservation Code would become a new chapter in Idaho Code as Title 39, Chapter 97. It prohibits local government entities from adopting any energy codes that differ or are more extensive. It would not change the rule-making authority for the Building Code Board under the Division of Occupational and Professional Licenses.

It does not affect rental property, nor long-term leases

and uses of public property by private entities.

This legislation would allow the lists of those individuals who have died become public to better validate and clean voter registration roles.

**Blake Youde** testified **in opposition** of **H 659**. He represents Idaho Association of County Recorders and Clerks. Stating their concern with the interference with the Idaho's Public Information laws which protects Idahoan's of the public release of information. The concern is with needing additional information to verify the identity of the person. If there are multiple people with the same name living in roughly the same area, more information would be needed to accurately identify the person. For example, this information could be a birth date, driver's license, or address. In response to committee questions, Mr. Youde responded that the biggest concern is that of other individuals using personal information of deceased persons in an inappropriate or wrong manner.

**Steve Madden**, from Ada County testified **in support** of **H 659**. He stated voter integrity is of the utmost importance. He stated people who are casting votes with integrity have the right to cast their vote.

**Chairman Crane** gave the option to **HOLD H 659** in committee for one day to come to a better resolution.

MOTION:

**Rep. Scott** made a motion to **HOLD H 659** in committee for time certain, February 23, 2022. **Motion carried by voice vote.**

for that to happen.

If a scheduled election date is upcoming within 120 days of a recall, then there would be no one appointed, but candidates would be allowed to run for the vacated trustee office position. If it exceeds 120 days, there will be a temporary replacement, and that position will be filled at the next election. Rep. Ehardt mentioned that the temporary replacement

has the opportunity to run for the appointed position.

In response to questions regarding if there is a possibility for school board members to meet after a recall where a few positions were vacated, and the rest of the school board members were to hold a meeting in executive session, **Quinn Perry**, the Deputy Director for the School Boards Association stated if there are two vacancies

the members are allowed to go into executive session on simple majority.

MOTION: Rep. Scott made a motion to send H 671 to the floor with a DO PASS

recommendation.

Phil McGrane, Elections Chair for the Idaho Associations of County Recorders

and Clerks stated his support for the bill.

VOTE ON MOTION:

Motion was carried by voice vote. Rep. Ehardt will sponsor the bill on the floor.

H 665: Rep. Blanksma presented H 665 which addresses the constitutional defense fund

and council. There are four members of the council; the Governor, the Attorney General, the Speaker of the House, and the Senate Pro Tempore. This legislation

removes the Attorney General from the council.

In response to a committee question, **Rep. Blanksma** stated this fund is a "slush fund" for the Attorney General, rather than using it for legislative purposes to defend

against constitutional intrusion.

MOTION: Rep. Skaug made a motion to send H 665 to the floor with a DO PASS

recommendation. Motion carried by voice vote. Rep. Blanksma will sponsor

the bill on the floor.

RS 29511: Rep. Skaug presented RS 29511 which requires cities and special districts that are subject to election consolidation to provide the clerk with adequate information regarding the new election zones. This makes it more efficient for the clerk to make the necessary adjustments before the election. MOTION: Rep. Scott made a motion to introduce RS 29511. Motion carried by voice vote. S 1274: Rep. Young presented S 1274 which directs the Secretary of State to order a post election audit of chosen election results after a primary or general election. This legislation intends to increase public confidence in election results by checking paper ballots. If there are findings, the Secretary of State has the option to audit additional ballots. Phil McGrane, Ada County Clerk testified in support of this bill. He added the integrity of the elections and importance of having the confidence of the public that the election results are accurate. Mr. McGrane stated the Cyber-Security Task Force, created by Governor Little focused on elections and one of the recommendations is to approve this specific legislation. In response to committee questions, Mr. McGrane added that every county in the state of Idaho uses paper ballots as the physical form where votes are cast, and most counties in Idaho use electronic equipment to read the ballots. The system is never connected to the internet to prohibit hacking. There is testing done through the electronic systems to check the accuracy of the machines. Using hand-marked ballots with knowing the results beforehand, running them through the machine, and checking that the results match the ballots ensures the machines are working accurately. The results are hand delivered from the tabulation room to the network computer and uploaded. Jason Hancock, Deputy Secretary of State stated his support of the bill, and mentioned the changes in the bill from the previous year. MOTION: Rep. Mathias made a motion to send S 1274 to the floor with a DO PASS recommendation. Motion carried by voice vote. Rep. Young will sponsor the bill on the floor.

RS 29613: Rep. Moon explained that RS 29613 replaces a previous RS and creates an

Election Integrity Fund with monies to defer the cost of state identification cards for those who cannot afford one. She reviewed the distribution of funds for this new process, and expressed her belief that the fiscal note was a high estimate based on

the expected number of people that would use this service.

In response to committee questions, Rep. Moon clarified that a person with a state

driver's license would not need a state identification card to vote.

MOTION: Rep. Scott made a motion to introduce RS 29613. Motion carried by voice vote.

RS 29628: Rep. Giddings presented RS 29628, which would prevent drop boxes for ballot

collecting. She discussed ballot harvesting that has been seen around the country, and believes it is not the best way to collect ballots. She pointed out that drop boxes can be an opportunity for elections to be disrupted by fire, flood or food

in the drop boxes.

Some committee members requested examples of ballot box issues in Idaho. **Rep. Giddings** reported that there were no examples in Idaho, but was concerned

because of recent occurrences in other states, specifically in Georgia.

Some committee members expressed their belief that this was a proactive way to

have election integrity in Idaho.

**MOTION:** Rep. Hanks made a motion to introduce RS 29628.

Committee members expressed some concern about so many proactive arguments not always being the best way to handle issues, but hoped to learn more information

as the RS is introduced.

**In support** of the motion, **Rep. Barbieri** believed if measures weren't taken, the burden would be put on the Secretary of State's office to verify which ballots are

legitimate and which are not.

Chairman Crane called for a vote to introduce RS 29628. Motion carried by

H 659: Rep. Giddings reminded the committee of H 659, legislation that would allow the RS 29659: public to examine records to ensure voters who have passed away are removed from voter rolls. She explained **RS 29659**, its replacement, would ensure that when Health and Welfare sends a list of those who have died, the information would include date of birth and enough information that names could accurately be pulled from voter rolls. New lines were added to make exceptions for provisions that made this information private. Blake Youde on behalf of the Idaho Association of County Recorders and Clerks, thanked all those who were involved in listening to concerns and creating a solution. MOTION: Rep. Scott made a motion to HOLD H 659 in committee. Motion carried by voice vote. MOTION: Rep. Scott made a motion to introduce RS 29659 and recommend it be sent directly to the Second Reading Calendar. Motion carried by voice vote. Rep. Giddings will sponsor the bill on the floor RS 29633: Rep. Young presented RS 29633. RS 29592: Rep. Dixon presented RS 29592 which brings new legislation forward stating that

> any non-government agency that facilitates refugees entering the state of Idaho provide background information and report it to their respective state agencies. This requires them to notify the Governor, the Dept. of Health & Welfare, and the

Dept. of Labor of their relocation.

Rep. Young made the comment of the difference in verbiage on the Statement of Purpose and legislation itself. Rep. Dixon noted the difference and stated the

changes would be made.

Rep. Scott made a motion to introduce RS 29592. MOTION:

In response to questions from the committee, **Rep. Dixon** clarified the term

"refugees" and its definition.

VOTE ON MOTION:

Motion carried by voice vote.

H 604:

Rep. Monks presented H 604 which expands on the Governor's executive order to RS 29668: prohibit the state of Idaho from requiring proof of vaccinations or immunizations, by

adding criteria regarding government employment, which allows for government employees to maintain their job without the need of a vaccine passport. It provides that individuals are allowed to receive help from the state, or enter into a location paid for by tax payers, without needing a vaccination passport. The major change in RS 29668 from H 604 is the specification that this applies solely to the coronavirus,

and then defining the verbiage "government venue."

MOTION: Rep. Palmer made a motion to HOLD H 604 in committee. Motion carried by

voice vote.

MOTION: Rep. Palmer made a motion to introduce RS 29668 and send it directly to the

second reading calendar. Rep. Mathias requested to be recorded as voting NAY.

**Rep. Dixon** will sponsor the bill on the floor.

RS 29652: Rep. Monks presented RS 29652. Rep. Monks asked for unanimous consent to

refer to other legislation. **S 1262** deals with section 46-1008 of Idaho Code. Rep.

Monks stated it is identical language to \$ 1262.

MOTION: Rep. Skaug made a motion to introduce RS 29652. Motion carried by voice vote.

RS 29591: Rep. Hanks presented RS 29591 which gives the opportunity for Idaho citizens to opt-out of smart meters. Rep. Hanks asked for verbiage to be added to the end of page 1, line 18, and mentioned that the emails she has been receiving from constituents have been concerning health issues. If constituents want to remove the meter, they have to pay for it and have no way to opt-out. There are several other states that do allow it. MOTION: **Rep. Barbieri** made a motion to introduce **RS 29591** with the indicated changes. Motion carried by voice vote. RS 29632: Rep. Andrus presented RS 29632 which eliminates the ability to send electronic voter registration via email, requires a full name on the registration device, exempts phone numbers and email addresses from public records requests, and states that members of the military can have their voter registration cancelled if they are not citizens of the United States. H 577: RS: 29672: **Rep. Young** presented **H 577** and **RS 29672**. These pieces of legislation tie together the religious exemptions of the coronavirus vaccinations with the existing protections of free exercise of religion. These protections are found in Idaho Code 73-402, the Freedom of Religion Protection Act. **RS 29672** makes the change, found in lines 32-34, which allows for a quicker resolution to the issue, rather than the time period listed in the original. Rep. Young requested that **H 577** be held in committee, and **RS 29672** be sent to the floor.

**MOTION:** Rep. Hanks made a motion to **HOLD H 577** in committee.

**Rep. Barbieri** made the comment that the burden on the employer interest outweighs the First Amendment interest of the employee. **Rep. Young** agreed with the statement.

with the statement.

**Del Chapel** testified **in support** of the bill. He also stated his opposition to the coronavirus vaccine, and how it is a violation of religious liberties, and that

individuals should not lose their jobs due to a vaccine.

**Samuel Edwards**, is a retired Coast Guard officer and works for one of Idaho's largest employers. He stated that he had to learn how to request a religious exemption for the vaccine, which he received, and spoke of his colleagues who were not as fortunate as he was and did not receive the religious exemption. The denials were made, in his opinion, because of the drastic description of their request that was misconstrued.

Rep. Skaug declared Rule 80 stating a possible conflict of interest, but stated

his support of the bill.

**RS 29475:** Rep. Dixon presented RS 29475 which gives procedure for federalism and allows

the members of the legislature to put a pause on the action, if they think the federal government is acting out of it's scope of authority. It is identical to the bill that was

passed last year.

MOTION: Rep. Furniss made a motion to introduce RS 29475. Motion carried by voice

vote. Rep. Dixon will sponsor the bill on the floor.

**H 695:** Rep. Young presented **H 695** which clarifies that the number of petition signatures

needed to force a recall election should be calculated by the number of electors that

are eligible to vote for the official whose election is in question.

MOTION: Rep. Hanks made a motion to send H 695 to the floor with a DO PASS

recommendation. Motion carried by voice vote. Rep. Young will sponsor the bill

on the floor.

H 693: Rep. Giddings presented H 693 which removes the use of ballot drop-off boxes.

It addresses the concern of drop-off boxes not being monitored and the potential

fraud or ballot box tampering that could take place.

Shiva Rajbahandari, Sam Sandermire, Hollie Conde, from Conservation Voters for Idaho, Alicia Abbott, Josie Christensen, and Angela Barkell all testified in opposition of the bill. The main points of their testimonies included worries that voters who work long hours, those who have irregular work schedules, elderly citizens, poll workers, voters who live a long distance from a voter poll or ballot drop-off location, and individuals who are too busy to make it to the polls on election days will suffer from the lack of ballot drop-off boxes and their opportunity to cast their vote will be foregone. There was also mention that ballot drop-off boxes feel safer than dropping a voter ballot in the mail due to the fear that it might get lost, and not make it the destination. Those individuals who are immunocompromised also became the topic of testimonies, in hopes that ballot drop-off boxes would remain available with the concern of COVID, and being able to socially distance.

**Rep. Giddings** concluded that not every county that have drop-off boxes have security or surveillance on the drop-off boxes. She stated that most counties provide postage for absentee ballots, and there are more ways to cast a vote than to use a drop-off box. The goal with this legislation is to rebuild trust in the voting process.

These Idaho State Identification cards will be made available for free, for voter registration purposes, for anyone who cannot afford them. Rep. Moon stated if one cannot provide the required forms of identification as a first time voter, then they are not eligible to vote. Each identification card that is issued will require a \$10 transfer from the Election Integrity Fund.

Asa Gray, the Elections Manager for Kootenai County, Bridget Gibson, Ethan Hobson, Chris Yamamoto, Emilia Anders, Isabella Fardette, Saumya Sarin, Amaia Clayton, and Hollie Conde all testified in opposition of the bill. The main concern from these testimonies was many first time voters do not have the identification cards required, nor the means to get one. There was speculation that the coming election was a motivator behind the legislation.

**Rep. Moon** concluded that the option to always get an Idaho identification card is available for those individuals, and it is essential to remove the affidavit. She ensured that every election is important and it is essential that there is matter in place to make sure that every vote is a legal one.

**MOTION:** Rep. Woodings made a motion to **HOLD H 692** in committee.

HCR 40: Rep. Scott presented HCR 40 which ends the State of Emergency implemented

by **Governor Brad Little.** Idaho has been in an emergency for 715 consecutive days. The emergency was put into effect when the uphill battle of the coronavirus began on March 15th, 2020. This legislation would urge the Governor to end the State of Emergency. As stated by Rep. Scott, the state of Idaho is no longer in an emergency and should follow the other states that have ended their state

of emergency.

During committee discussion, **Rep. Woodings** asked what the outcome would be for the 600 federal healthcare workers if the State of Emergency ended. She referred to Idaho's current low vaccination rate and the high hospitalizations. **Rep. Scott** stated those positions would be filled by citizens from Idaho, and she also

referred to \$2 billion in surplus that the State of Idaho has available.

Del Chapel, Steven Keiser, Nina Beesley, Rachelle Ottosen, and Michael Lewis

all testified in support of this legislation.

MOTION: Rep. Young made a motion to send HCR 40 to the floor with a DO PASS

recommendation.

that assists in resettlement of refugees to the State of Idaho, that they report the name, age, sex, country of origin, and reason for resettlement to specific state agencies. There were previous concerns regarding what the definition of the term "refugee" is, and also the purpose for including "reason for resettlement" in the

required report of information.

Del Chapel testified in support of the bill.

**Georgette Siqueiros**, the Development and Community Engagement Manager for the International Rescue Committee, testified **in opposition** of the bill. Ms. Siqueiros stated that if personal information were to be released, it could put a refugee at risk.

MOTION: Rep. Young made a motion to HOLD H 704 in committee. Motion carried by

voice vote.

**MOTION:** Rep. Palmer made a motion to introduce RS 29699 and recommend it be sent

directly to the second reading calendar.

H 666:

**Rep. DeMordaunt** presented **H 666** which prohibits the distribution of harmful materials to children. These specific materials include obscene depictions in movies, books, and other media. This bill would remove all of these harmful materials from school, libraries, universities, and museums. Rep. DeMordaunt stated that none of these materials should be used as a tool to teach human sexuality, and should never be included in schools or public libraries.

**Stephanie Gifford and Blaine Conzatti** both testified **in support** of the bill, and also provided information used in the introduction of the bill. Ms. Gifford stated the explicit material provided to the committee was found in the juvenile section of public libraries in Idaho.

**Erin Kennedy and Huda Shaltry** testified **in opposition** and stated the bill was written with vague verbiage, stating the bill saying "harmful materials" isn't specific enough, and there needs to be more description on whether it is regarding sexual material, pornographic materials, or materials with violence, or about guns, or even mental health conditions. There were comments on whether or not the legislation is about removing books from public libraries, or if it is to criminalize librarians who are giving these books out to children.

Nina Beesley, Kara Claridge, Craig Cobia, Michael Hon, Debbie Alis, and Rachelle Otteson all testified in support of H 666. The common factor was that it was a protection against harmful material for children, and there are harmful materials readily available to children in libraries and schools that shouldn't be.

**Rep. DeMordaunt** clarified that the claim this bill would criminalise librarians is false, and the goal is to not make the materials available to children.

**MOTION:** 

**Rep. Young** made a motion to send **H 666** to the floor with a **DO PASS** recommendation.

**Rep. Woodings** mentioned Title 18 of Idaho Code, and stated this legislation does in fact criminalize librarians, and does not correct the problem that it is intending to correct.

**HR 19:** Rep. Scott presented **HR 19** which is a House Resolution urging the Supreme

Court to overturn their ruling regarding abortion. In her presentation, Rep. Scott stated that each state should make their own decisions regarding abortion, and this resolution urges the Supreme Court to give Idaho that privilege. Rep. Scott provided the example that a lot of states have ignored the federal court's decision regarding the use of marijuana, and she stated much like that, each state should

have the chance to make their own decisions.

MOTION: Rep. Barbieri made a motion to send HR 19 to the floor with a DO PASS

recommendation.

Blaine Conzatti and David Ripley both testified in support of the resolution, and

both mentioned it is the duty of this bill to protect the lives of the unborn.

Chelsea Gaona-Lincoln and Mistie DelliCarpini-Tolman both testified in opposition to the resolution. The common conclusion was that all individuals should be able to make decisions regarding their own body. There were also comments that there are bigger problems the legislature should focus on.

Rep. Armstrong voiced his strong support for the resolution, and asked that it

be on the record.

H 675:

**Rep. Skaug** presented **H 675** which amends the existing ban on female genital mutilation and adds puberty blockers, cross-sex hormones, and sex reassignment surgeries when administered to children struggling with gender dysphoria. The concern is that these medical interventions are almost always irreversible, some can potentially sterilize children and mutilate healthy body organs. Rep. Skaug stated that gender dysphoria is a term applied by psychologists to describe individuals who are confused by their sex. He also stated treatment for children struggling with gender dysphoria should be counseling and talk therapy, and it is not intended to take away treatment from children; it is a bill to help them get proper treatment. Rep. Skaug stated that children are too young to make the decision to change their gender, and explained that the law doesn't allow for underage children to get a tattoo, drink alcohol, or sign a legal contract.

**Blaine Conzatti** testified **in support** of the bill. In response to committee questions, Mr. Conzatti stated that he was unaware of any incidences, in the United States, where individuals who were allegedly harmed sued their doctors.

Kaitlyn Nevel, Andrew Perkins, Calvin Udall, Eve Michelle, Alicia Abbott, Joe States, Lauren Bramwell, Chelsea Gaona-Lincoln, Susie Keller, all testified in opposition of the bill. Many testified that they have friends, children, family members who are transgender and this would hinder their ability to become who they feel they are meant to be. There was also mention that this is a removal of rights for those individuals who are transitioning or wishing to transition. Some individuals testified that they are in the process of transitioning, and that some of the information regarding sterilization is incorrect. Another concern was the criminalization of otherwise legal and evidence based medical care performed by physicians.

Sebastian Griffin, Erin Brewer, Billy Burleigh, Ted Hudacko, Dr. Quentin Van Meter all testified in support of the bill. The common conclusion was that children under the age of 18 should not be able to access cross-sex hormones, puberty blockers, and gender altering surgery.

**Dr. William Malone** testified **in support** of the bill. He is a practicing adolescent and adult endocrinologist. He stated that there is no factual evidence that puberty blockers, cross-sex hormones, and gender altering surgery decreases the rate of suicide, or improve the mental health of children suffering from gender dysphoria. He stated that lawsuits are ongoing due to the regret they feel following the altering surgery. In response to committee questions, Dr. Malone stated that he is aware of minors being prescribed puberty blockers, cross-sex hormones, sex reassignment surgeries, etc. to underage children happening in Idaho.

**Rep. Skaug** declared Rule 80 stating a possible conflict of interest.

In conclusion, **Rep. Skaug** re-capped the impact of the testifiers and the information they provided.

Family members who are "harmed" by the abortion of an immediate

family member, can be compensated \$20,000.

Blaine Conzatti, President of Idaho Family Policy Center, testified in support of the bill. He stated that **S 1309** adds a private enforcement mechanism to the heart beat law that was signed last year, and it is modeled after the Texas heartbeat bill. He also stated that it does not create civil liability for those that aid in an unlawful abortion, and it restricts civil liability to the abortionist who committed the crime. He stated that life does not begin at the first sign of a heartbeat but it begins at conception, and deserves legal protection, and that a detected heartbeat is a reliable indicator that life exists.

Saumya Sarin, Vanessa Rosenbaum, Nydia MacDonald, Chelsea Gaona Lincoln, Scott Watson, Sophia Drigg, Amber Olah, Jo Smith, Lindsay Van Allen, Mistie DelliCarpini-Tolman all testified in opposition to the bill. The common statements were regarding the risk of women's lives, and unsafe abortions that could be performed if this option is taken away from women.

Pro-Life (Marvin Richardson), Jacqueline Wakefield, Tammy Payne, Karin Simkins, Robin Watters, Linda Thomas, Heather Lawless, Jason Heering, and Kelly Cope all testified in support of the bill. RS 29789: Rep. Moon introduced RS 29789 which is an amendment of the Election Code. It

removes the affidavit of invalid voters, and adds a change in requirement of voter identification that allows for voter registration. If an individual cannot afford an identification card, identification will be made available at no charge to the voter, covered by the Voter Integrity Fund. Each identification card will require a \$10 transfer from the Voter Integrity Fund. It also removes the emergency clause, and the effective date is July 1, 2022. On page 2, "acceptable address verification documents" is added, and this covers any concerns from the previous meeting.

cosmetology license. Many other states have exempted hair braiding from needing a cosmetologist license, yet Idaho has not. Currently, there is a federal lawsuit regarding the ability of an individual to practice and perform hair braiding without needing to go to cosmetology school and obtain the licensure that comes with it.

In response to committee questions, **Rep. Nash** stated the Division of Occupational Licensing has had conversations with cosmetology schools and that they have been positive. He also stated he is unaware of any schooling for hair braiding, but braiding is not consistent with the skills cosmetologists are learning in school. **Rep. Scott** stated this legislation will give prisoners the opportunity to leave prisons with

new skills and have the chance to make a living for themselves.

H 682: Rep. Skaug presented H 682 which adds to the existing law, requiring a notification

of boundary change for election zones, districts, and subdistricts.

**Jason Hancock**, Deputy Secretary of State, testified **in support** of the bill. He stated this will create a uniform standard of notification that within 30 days after a taxing district that is subject to election consolidation has made subdivisional boundary changes or within 30 days of the filing for candidates, whichever comes sooner, county clerks need to be notified. He stated that it also includes school districts.

the rules and guidelines.

**Kathy Dawes** spoke **in opposition** of the bill, stating that an individual living in an assisted living facility should have the freedom to choose who they would like to assist them in their voting process. She stated the elections office already has the option to assist the public, but no action has taken place yet. She stated there is a large fiscal impact with adding employment and spending the time to

train employees.

**Rep. Troy** restated this bill will only go into effect if the assisted living facility calls the county election office to ask for assistance for their residents. She stated it is not required, it is only a service. This allows for an opportunity to receive assistance that is non-partisan when filling out their ballots. She stated that she worked with AARP and that they are in support of the language added to the bill.

Rep. Mathias stated he has concerns that this bill is trying to do too much, and

He mentioned the reasoning behind removing emails is because they are used as log-ins for certain accounts, and often personal

accounts, which is a risk to cyber-security.

Jason Hancock testified in opposition of this bill as it is written, and stated Secretary Denney opposes this bill as it is written. He mentioned that the Secretary of State's office takes cyber-security very seriously and this bill does include a portion of authentication that could be used to hack or otherwise invade the personal accounts of candidates. With the amendments to the bill, Mr. Hancock stated the Secretary of State's office has no issue with the bill and is in support

of those amendments.

**MOTION:** Rep. Gannon made a motion to send S 1338 to General Orders.

**Elinor Chehey,** representing Legal Women Voters of Idaho, testified **in support** of **S 1338** the way it is written. She is the chair of the Vote 411 Project, which is an online voter guide that includes mapping data and provides information about each candidate to voters. She stated the project must have a list of the emails in order to contact the candidate and provide them with the link to their space on the website.
