AN ACT

RELATING TO THE APPROPRIATION TO THE OFFICE OF THE STATE TREASURER; APPROPRIATING MONEYS TO THE OFFICE OF THE STATE TREASURER FOR FISCAL YEAR
2024; LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT POSITIONS; PROVIDING REQUIREMENTS REGARDING PAYMENT OF BANK SERVICE FEES;
PROVIDING REAPPROPRIATION AUTHORITY; AND DECLARING AN EMERGENCY AND
PROVIDING AN EFFECTIVE DATE.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. There is hereby appropriated to the Office of the State Trea-10 surer the following amounts to be expended according to the designated ex-11 pense classes from the listed funds for the period July 1, 2023, through June 12 30, 2024:

SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519, Idaho Code, the Office of the State Treasurer is authorized no more than twenty-eight (28.00) full-time equivalent positions at any point during the period July 1, 2023, through June 30, 2024, unless specifically authorized by the Governor. The Joint Finance-Appropriations Committee will be notified promptly of any increased positions so authorized.

SECTION 3. PAYMENT OF BANK SERVICE FEES. Of the amount appropriated
 in Section 1 of this act, no more than \$406,600 from the General Fund and
 \$221,700 from the Professional Services Fund may be used for the payment of
 bank service fees for the period July 1, 2023, through June 30, 2024.

SECTION 4. REAPPROPRIATION AUTHORITY. There is hereby reappropriated to the Office of the State Treasurer any unexpended and unencumbered balances appropriated to the Office of the State Treasurer from the Idaho Workforce Housing Fund for fiscal year 2023 for the period July 1, 2023, through June 30, 2024. The Office of the State Controller shall confirm the reappropriation amount with the Legislative Services Office prior to processing the reappropriation authorized herein.

8 SECTION 5. An emergency existing therefor, which emergency is hereby
9 declared to exist, this act shall be in full force and effect on and after
10 July 1, 2023.
