## STATEMENT OF PURPOSE

## RS30623 / S1172

This is the FY 2024 original appropriation bill for the State Appellate Public Defender. It appropriates a total of \$4,038,900 and caps the number of authorized full-time equivalent positions at 26.00. The bill funds three line items, which provides additional funds for a Capital Litigation Attorney, parity salary increases for attorneys, and an 11% salary increase for staff and attorneys. Also included in this bill is a onetime FY 2023 supplemental, which provides \$67,500 for additional electronic records storage capacity. A supplemental for capital cases was approved earlier this session and sent out as a separate bill.
