H 24: Rep. Blanksma, presented H 24, and said Workforce Development amends

and adds to existing law to establish the Idaho Launch Grant Program to revise provisions regarding the In-Demand Careers Fund. She said this is a grant program and not scholarship program. She said current workforce training focuses on adults and explained this program is for secondary schools and uses aptitude testing to discover student interests. Rep. Blanksma said **H 24** is a job driven program, not degree driven. She explained how this program meets changing educational needs.

In response to Committee questions, **Rep. Blanksma** said **H 24** allows opportunities to students who cannot afford College. She said by targeting and training for In-Demand Idaho jobs, the likelihood of students staying in Idaho after training completion is high.

Alex LaBeau, IACI, and Adam Jones, BSU, spoke in support of H 24, explaining how the investment will benefit Idaho.

Anna Miller, from the Idaho Freedom Foundation, and **Victoria Young,** of Caldwell, voiced their **opposition** to **H 24**, explaining that businesses should not get paid to train employees. They said money should be spent on improving existing school education.

Liz Hatter, Idaho State Dental Association, **Deni Haney,** Winco Foods, **Peyton Nunes,** Lineman College Nurses, **Joe Maloney,** and **Cally Roach,** voiced their support for **H 24.** They spoke about workforce shortages and high availability for more skilled jobs. They explained how **H 24** can help fill in-demand jobs.

Gordon Jones, President, CWI, and **Debbie Critchfield,** Superintendent of Public Instruction, State Department of Education, explained how **H 24** would provide more opportunities for education that can benefit Idaho.

Reps. Price, Clow, Mendive, and Boyle voiced their **opposition** of **H 24** and questioned if giving money is really the solution or just taking responsibility from students. They expressed capacity concerns and possible solutions in high school and community college programs.

Reps. Lanting, Garner, Sauter and Nelsen spoke **in support** of **H 24**, stating the need for skilled employees in the workforce and how keeping money in the state is beneficial. They said **H 24** only provides partial funding for workforce training and students will need to earn the remainder.

Reps. Wisniewski, Ehardt, and Hawkins spoke in **opposition** to **H 24** and spoke about the proper role of government regarding K-12 education. They expressed concern over test results determining career paths and taking away financial obligations and growth that come from earning an education. They suggested holding Universities accountable for job placement.

Reps. Berch, Mathias, and Hill voiced their **support** for **H 24**, saying cost is the number one reason students do not continue education.

Chair Yamamoto and Vice Chair McCann spoke about working with Idaho students and **support** for **H 24**. They said workers build the economy and **H 24** provides opportunities to more students. They spoke about the constitution and the obligation to educate people. They said students should have a choice in workforce training.

MOTION: Rep. Lanting made a motion to send H 24 to the floor with a DO PASS

recommendation.

a parent or quardian present.

Kristi Hardy, Jessica Fairbanks, and Quinn Perry spoke in support of H 163. They spoke about schools within the same district having different policies and confusion with parent and teacher communication. They said there should be a

school board and administration balance.

Reps. Hill, Ehardt, Hawkins, and Mendive, spoke in support of H 163. They said parents have rights and there should not be secret survey's or agenda's. They said communication with parents is key to a successful education. Reps. Clow, McCann, and Berch spoke in support of H 163. They said they want to assume the best in people but sometimes parents don't get involved and laws need to be

passed to give more direction.

Rep. Ehardt said she would like to see "male restrooms excluded," added to the

She voiced her concerns about the Department of Education overseeing and

monitoring hygiene products.

Reps. Nelsen and Garner spoke in support of RS 30400. They are in support of

local school board control and do not think legislation should be so technical.

Rep. Hawkins spoke about the safety of female hygiene products and his worry

over the possible risks associated with imposing all school districts to provide these

products.

free of charge, only in female and unisex restrooms within all public school buildings

Opportunity Program, a savings account for students.

RS 29942C1: Rep. Galaviz presented RS 29942C1, proposed legislation which would amend

teacher certification standards in rule.

vote.

H 220: Rep. Shepherd presented H 220, legislation which would add to existing law to

He said the Governor currently appoints the members of the State Board of Education members.

Reps. Garner, Sauter, Nelsen and Galaviz spoke **in opposition** to **H 204.** They spoke about concerns over election costs and travel expenses for board members located all over the state to attend meetings and functions. They said State Board members are appointed by the Governor who is an elected official. They said they fear the focus would be on political campaigning rather than education.

Branden Durst, testified **in support** of **H 204**. He said currently there is no guarantee of demographic representation.

Rep. Clow said State Board members are not currently paid positions but **H 204** would make this a paid position.

MOTION:

Rep. Hawkins made a motion to send **H 204** to the floor with a **DO PASS** recommendation.

SUBSTITUTE MOTION:

Chair Yamamoto called the meeting to order at 8:00 am.

MOTION: Rep. Sauter made a motion to approve the minutes for the February 14, 2023

meeting. Motion carried by voice vote.

MOTION: Rep. Galaviz made a motion to approve the minutes for the February 14, 2023 and

February 21, 2023 sub-committee meetings. Motion carried by voice vote.

H 139: Rep. Crane (12) presented H 139, which would prohibit distribution of certain

materials to children in public libraries and public school libraries. He spoke about the role of temperance and morality in the Idaho Constitution. He said librarians have an obligation to protect minors and they should take reasonable and responsible efforts to restrict inappropriate material. Rep. Crane (12) yielded his time to **Blaine Conzatti**, Idaho Family Policy Center, who spoke about the statewide problem of access to inappropriate and obscene materials in public and school libraries. He stated the bill outlines legal ramifications if reasonable efforts to restrict inappropriate material are not made.

In response to questions, **Mr. Conzatti** explained the legislation establishes a duty of care and relies on a reasonableness standard, so it is not intended to be burdensome to libraries. He also stated the plaintiff bears the burden of proof, and courts have discretion to award expenses to the defendant if the lawsuit is deemed frivolous.

As a co-sponsor of **H 139**, **Sen. Carlson** continued presenting the bill and stated this legislation is not trying to punish librarians, but is intended to hold the institution responsible. She also clarified literary works are not included as harmful materials in the bill.

Ron Nate, Idaho Freedom Foundation, testified **in support** of **H 139**. He spoke about harmful materials in libraries and the need for accountability. It was explained the significance of the penalty is commensurate with the harm to children and would help enforce the law.

Sherry Scheline, testified **in opposition** to **H 139**, every library is different across the state and the financial impacts on small libraries would be detrimental.

In answer to a question, **Ms. Scheline** explained discerning what is objectionable material is difficult. As an example, she stated even the Bible has excerpts that could be considered obscene.

Heather Greenman testified **in support** of **H 139** and requested to read excerpts from objectionable books. She spoke about her efforts to have harmful material removed from her library. She was denied the request.

Chair Yamamoto stated she would not allow reading excerpts from books in committee, but testifiers could provide written examples, or pass around exhibits. **Rep. Wisniewski** objected to the Chairman's statement.

In response to a question, **Ms. Greenman** stated her library board said it was following state law when it denied the request to remove the books in question.

Bonnie Shuster, Heather Stout, Gregory Taylor, Alex Stein, Sherry Hughes, and Lance McGrath, Idaho Library Association, spoke in opposition to H 139. Their concerns centered on local control; parental rights and responsibility; and restricting access to constitutionally protected material.

Response to committee questions included emphatic statements confirming librarians do not provide obscene material to children, and local library board policy sets the age a child can go to the library unaccompanied.

Joseph Greenman, Lyle Johnstone, Nina Beesley, Kathy Thompsen, Rachelle Ottosen, Community Library Network, and Rep. Crane (13) spoke in support of H 139. Their support centered on children being harmed and having a right to their innocence; access to pornography can lead to addiction; and the government's constitutional fiduciary responsibility to prevent children's exposure to pornographic material. Rep. Crane (13) explained the bill allows for local discretion and policies, but suggesting the bill go the General Orders in an effort to bring the parties together to reach a compromise.

In closing, **Rep. Crane (12)** and **Sen. Carlson** stated the bill was not a book ban, it was only asking libraries to make reasonable efforts to restrict minors' access to harmful materials.

MOTION:

Rep. Mendive made a motion to send **H 139** to the floor with a **DO PASS** recommendation.

In answer to questions, **Mr. Conzatti** explained all obscene acts are under the purview of the definition included in the bill.

SUBSTITUTE MOTION:

Rep. Garner made a substitute motion to **HOLD H 139** in committee.

Committee members speaking **in support** of the substitute motion explained concerns about excessive monetary damages; no automatic ability for libraries to recover attorney's fees if legal proceedings are judged as frivolous; impacts on local control; freedom of speech infringement; and lack of definitions to guide what is of literary value or obscene.

Committee members speaking **in opposition** to the substitute motion stated it protects children from graphic pornography.

AMENDED SUBSTITUTE MOTION:

Rep. Clow made an amended substitute motion to send **H 139** to General Orders.

Committee members speaking **in support** of the amended substitute motion stated the amount of the damages could be easily fixed in General Orders.

Committee members speaking **in opposition** to the amended substitute motion expressed concerns the word pornography is not included in the bill, and definitions of law need to be more than a list of examples.

MOTION:

Rep. McCann made a motion to call for the previous question.

Rep. Berch asked for clarification on General Orders procedures. **Rep. Clow** provided clarification.

ROLL CALL VOTE:

Roll call vote was requested. Having failed to meet the two-thirds present requirement, the Motion failed by a vote of 10 AYE and 7 NAY. Voting in favor of the motion: Reps. McCann, Clow, Garner, Lanting, Nelsen, Sauter, Berch, Galaviz, Mathias, Yamamoto. Voting in opposition to the motion: Reps. Boyle, Mendive, Ehardt, Wisniewski, Hawkins, Hill, Price

Committee members speaking **in opposition** to the amended substitute motion, stated the bill needed a number of concerns to be addressed and General Orders was not adequate to address them.

Committee members speaking **in support** of the amended substitute motion stated the debate needed to occur on the House floor, and a vote otherwise would essentially kill the bill.

ROLL CALL VOTE ON AMENDED SUBSTITUTE MOTION: Chair Yamamoto called for a roll call vote on the amended substitute motion to send H 139 to General Orders. Motion failed by a vote of 8 AYE and 9 NAY. Voting in favor of the motion: Reps. Boyle, Clow, Mendive, Ehardt, Wisniewski, Hawkins, Hill, Price. Voting in opposition to the motion: Reps. McCann, Garner, Lanting, Nelsen, Sauter, Berch, Galaviz, Mathias, Yamamoto.

ROLL CALL VOTE ON SUBSTITUTE MOTION: Chair Yamamoto called for a roll call vote on the substitute motion to HOLD H 139 in committee. Motion carried by a vote of 9 AYE and 8 NAY. Voting in favor of the motion: Reps. McCann, Garner, Lanting, Nelsen, Sauter, Berch, Galaviz, Mathias, Yamamoto. Voting in opposition to the motion: Reps. Boyle, Clow, Mendive, Ehardt, Wisniewski, Hawkins, Hill, Price.

H 227:

Rep. Nelsen presented **H 227**. This bill sets a policy and process for public schools, public charter schools and public libraries to establish policies addressing complaints; organization of materials, including sectioning off certain materials; and issuing library cards. He stated he trusts local control and issues can be addressed at the local ballot box.

In answer to questions, **Rep. Nelsen** explained public charter schools are addressed separately but consistently in the bill because public schools and public charter schools are governed under different sections of code. He clarified the process for issuing library cards to children, and emphasized parental responsibility for monitoring children's activity in libraries.

Lyle Johnstone, Nina Beesley, Destinie Hart, Charity Myser and Ron Nate, Idaho Freedom Foundation, spoke in opposition to H 227. They were concerned self-governance without penalty is ineffective and the bill does not include standards for the written word. Ms. Hart did not believe any bill addressing this matter was necessary.

Margaret Ellsworth, Lance McGrath, Idaho Library Association, and Jessica Dorr, Boise Public Library, spoke in support of H 227. They stated the bill takes reasonable steps to restrict access to certain materials from children, while also protecting adults' rights to constitutionally protected materials. It provides a consistent framework for how local libraries can establish safeguards and empowers parents to make choices about what is best for their children.

In answer to questions, **Rep. Nelsen** confirmed the bill addresses written works and while it is not a satisfying solution for everyone, it provides a way forward for communities to find balance.

MOTION:

Rep. Garner made a motion to send **H 227** to the floor with a **DO PASS** recommendation.

SUBSTITUTE
MOTION:

Rep. Ehardt made a substitution motion to HOLD H 227 in committee to a time certain of March 25, 2023.

Committee members speaking in support of the motion stated the library association had input into this bill and only protects librarians, but doesn't meaningfully address the unheeded concerns of parents.

Committee members speaking in opposition to the substitute motion stated it was time to make a decision, or bring the parties together to reach a resolution sooner than the motion allows.

Chair Yamamoto called the meeting to order at 8:00 am.

H 267: Rep. Wheeler presented H 267, legislation which would add to existing law to

establish the Career Ready Students Program and the Added Cost Funding

Support Program.

Debbie Critchfield, Superintendent of Public Instruction, State Department of Education, said **H 267** would provide opportunities to drive meaningful outcomes in each community. She said the ultimate goal is for school districts and communities

to work together to determine needs.

Rep. Clow spoke **in support of H 267.** He said the bill references the State Board of Career Technical Education, which does not exist. **Matt Freeman,** Executive Director. State Board of Education said the State Board of Education is the board

of CTE.

John Silveria and Steve Thomas testified **in support** of **H 267**. They spoke about industries in need of skilled workers. They spoke about career ready students and

said **H 267** would help Idaho students find careers in Idaho.

Shawn Dygert and Peggy Hoy testified **in support** of **H 267**. They said this bill would allow students to have hands-on experiences. They spoke about CTE programs and the training provided for the agricultural, manufacturing and health

care fields.

MOTION: Rep. Garner made a motion to send H 267 to the floor with a DO PASS

recommendation.

Rep. Hawkins spoke **in opposition** to **H 267** and voiced his concern about spending money on programs for students when industries should be training employees. Committee members spoke about students being introduced to different careers at an early age, and about prioritizing education for local industries and said companies do train employees. **Superintendent Critchfield** spoke about

student achievement and the many career options available.

Other committee members spoke about undue pressure put on students too early in life and if money is spent on a student, they may feel pressure to stick with a particular career. **Superintendent Critchfield** said this program would introduce

many options to students.

Committee members spoke about accountability, the skills being taught in school and perfecting those skills after graduation, and about the educational constitution requirements. They said the current school curriculum is to prepare students to attend college. They said **H 267** would allow students to have access to different types of career opportunities, and some do not require a college education.

Roll call vote requested. Motion carried by a vote of 14 AYE, 1 NAY, and 2 Absent/Excused. Voting in favor of the motion: Reps. McCann, Clow, Mendive, Wisniewski, Garner, Hill, Lanting, Nelsen, Price, Sauter, Berch, Galaviz, Mathias, and Yamamoto. Voting in opposition of the motion: Rep. Hawkins. Reps. H 225:

Chair Yamamoto presented **H 225**, legislation which would revise provisions regarding school attendance and to prohibit certain funding for home schooled children. She said **H 225** would define home school as education funded by parents. She said home schooled families do not take state or federal funds.

Linda Patchin, Home School Idaho, spoke about the history and growth of home school in Idaho.

Johanna Ireland and Audra Tally testified in support of H 225. They spoke about the differences between public, private, online, and home school. They said all costs for home schooled children are paid for by parents. They said dual enrollment would not be defined as public school.

Annie Grey, Melissa Nash, and Andrea Gremmert testified in support of H 225. They spoke about the experience of home schooling children, testing, and co-op groups. They said H 225 would separate schools legally.

Committee members spoke about home school students who are enrolled in public school athletics. They said the fee charged to parents does not cover all expenses, therefore, they are accepting public funds.

Reps. Price and Hawkins spoke **in opposition** to **H 225.** They spoke about legislature involvement in the home school community.

MOTION:

Rep. Mendive made a motion to RETURN H 225 to the sponsor.

WITHDRAWN MOTION:

Rep. Mendive asked unanimous consent to withdraw his motion to **RETURN H 225** to the sponsor. There being no objection, the request was granted.

MOTION:

Rep. Mendive made a motion to **HOLD H 225** in committee. **Motion carried** by voice vote.

Vice Chair McCann returned the gavel to Chair Yamamoto.

H 272:

Rep. Price presented **H 272**, legislation which would amend existing law, to require a parent's written permission for a student to participate in sex education classes. She said this bill would help parents feel like they are more in control of what is being taught.

Reps. Lanting, Sauter and McCann spoke in opposition to **H 272** and said they do not like the one-sided attorney fees. They said law already provides for this recourse.

In response to questions, **Quinn Perry**, Idaho School Boards Association, said parents would have access to educational material on line.

Rep. Galaviz spoke about the few permission slips which get returned to schools and said this would not be a successful option. She said there would need to be a better way to get family consent without putting undue burden on the education system.

Nikole Trakel and Chaleena Dean testified **in support** of **H 272**, and spoke about the current opt-out process and how it didn't work for their children. They said teachers would have a plan in place for students who do not opt-in to instruction.

Amy Henry testified **in support** of **H 272** and said this legislation is written by a former educator. She said the opt-in option allows parents to have control. She said the opt-in form could be part of the registration documents given out at the beginning of the year.

Nora Morse and Madeline Patterson testified **in opposition** to **H 272**, and spoke about the importance of creating a safe environment to learn about sexual education. They spoke about students who would miss out on the opportunity to learn correct information because not all parents are actively involved in teaching this information.

MOTION: Rep. Clow made a motion to send H 272 to the floor with a DO PASS

recommendation.

SUBSTITUTE MOTION:

Rep. Berch made a substitute motion to **HOLD H 272** in committee.

Rep. Berch said the current will of the legislature is for students to take sex education unless a parent opts-out. He said H 272 would make it so students would not receive this fundamental knowledge unless a parent opts-in. He said parental

rights already exist with the opt-out program.

Rep. Mathias spoke in opposition to H 272. He said he doesn't believe this bill is

well tailored for the circumstance and thinks it should be re-written.

Hawkins and Price spoke in opposition to RS 30519 and said students can go to the school nurse or principal's office to get free products. **Rep.** McCann said many students are embarrassed to ask an adult for feminine hygiene products and they are not currently provided in restrooms. **Rep.** Lanting said many schools do not staff nurses.

MOTION:

Rep. Galaviz made a motion to introduce RS 30519.

Rep. Galaviz spoke **in support** of **RS 30519**. She spoke about poverty and the need to help families by providing female hygiene products.

Rep. Hawkins said he is concerned about products being supplied by a company making the bill. **Rep. McCann** said legislation does not require products to be purchased from any one company.

SUBSTITUTE MOTION:

Rep. Ehardt made a motion to introduce **RS 30519** with the following amendments: Change "human" to "female" and to add a section to include "this shall not apply to restrooms of men or boys." **Motion carried by voice vote.**

RS 30129C1: Rep. Dixon (1) presented RS 30129C1, proposed legislation which would amend

existing law to revise the definition of "authorized chartering entity." He said the Charter School Commission is overloaded with requests for new charter schools and this would allow for sectarian higher education institutes to act as a charter school authorizer.

Terry Ryan, Bluum, and **Blake Youde**, Charter School Network, testified **in support of S 1042aa** and said this bill would double the number of schools eligible to participate in the Public Charter Schools Facilities Program. They spoke about the impact for at risk youth. They said the revolving loan fund allows money to be

put back into classrooms instead of banks.

Andy Johnson, Sage International Network of Schools, Bryan Fletcher, Gem Prep Schools, Steve Lambert, Treasure Valley Classical Academy, and Marc Carignan, Idaho Charter School Network, testified in support of S 1042aa. They spoke about the money schools have saved because of low interest rate bonds and how the money was able to go toward student growth. They said the school limit cap should be raised so more schools can participate in the Credit Enhancement Program.

CJ Watson, Elevate Academy, testified in support of S 1042aa and spoke about

at-risk youth and the process of tracking growth.

MOTION: Rep. Clow made a motion to send S 1042aa to the floor with a DO PASS

recommendation.

Reps. Mathias and Berch spoke **in support** of **S 1042aa** and requested to be recorded for recognizing the large decline in the condition of traditional public schools. They said they believe traditional public school facilities should also be

addressed.

Reps. McCann and Ehardt spoke **in support** of **S 1042aa**. They spoke about the innovation and creativity used to make the Credit Enhancement Program which gives parents choices. They said legislation similar to this should be created for

traditional public schools.

Chair Yamamoto called for a vote on the motion to send S 1042aa to the floor with a DO PASS recommendation. Motion carried by voice vote. Rep. Horman will sponsor the bill on the floor.

RS 30609:

Rep. Lanting presented **RS 30609**, proposed legislation which would require schools used for polling locations, to not hold in-person instruction on election days to maintain safety for students. **RS 30609** replaces **H 111** with the following amendments: School districts would have discretion to hold on-line instruction or not hold school on election days. Rep. Lanting said school districts would have discretion to allow schools not being used for polling locations, to hold in-person instruction.

Phil McGrane, Secretary of State, State of Idaho, in response to questions said the legislation would only apply to the May and November general elections. He said this legislation would allow for calendar scheduling to minimize disruption.

Reps. Nelsen and Mathias spoke **in support** of **RS 30609** and said they like the local control which allows school districts to choose what is best for the students and community.

Rep. Price spoke **in opposition** to **RS 30609**. She said this legislation implies voters can't be trusted. She said school districts should be encouraged to hold in-service on election days and questions why a bill is necessary.

Chair Yamamoto spoke **in support** of **RS 30609.** She said student safety is the objective of this legislation. She spoke about in-person voting and the shortage of ADA compliant buildings available for polling locations. She said instructional changes would be on the school district calendars in order for families to make the necessary adjustments.

MOTION:

Rep. Nelsen made a motion to introduce RS 30609.

SUBSTITUTE MOTION:

Rep. Berch made a substitute motion to introduce **RS 30609** and recommend it be sent directly to the Second Reading Calendar. **Motion carried by voice vote. Rep. Price** requested to be recorded as voting **NAY. Rep. Lanting** will sponsor the bill on the floor.

ADJOURN:

There being no further business to come before the committee, the meeting adjourned at 9:04 am.

to allow for more charter schools in Idaho.

Rep. Garner spoke in opposition to H 290. He spoke about the current process to

create charter schools and believes it is working well.

In response to questions, **Rep. Dixon (1)** spoke about the Idaho charter school standards and the financial stability of institutions seeking to be an authorizer.

In response to questions, **Tracie Bent,** Chief Planning and Policy Officer, Idaho State Board of Education, spoke about accreditation organizations and programs. She said the Northwest Commission on Colleges and Universities is the current

accreditation organization.

Karen Hansen testified **in opposition to H 290** and said this bill is constitutionally unsound. She spoke about the separation of church and state and the use of

tax dollars.

Paul Stark, Director, Idaho Education Association, testified **in opposition** to **H 290**. He said he believes the definition for accreditation is too broad and vague.

Terry Ryan, Bluum, spoke **in support** of **H 290.** He spoke about other states which allow sectarian universities to be authorizers for charter schools. In response to questions, he spoke about the application, approval, and fee processes. He said the authorized institutes do not run the charter schools.

Rep. Mathias spoke **in opposition** to **H 290** and said not all nationally accredited authorizers are the same.

Rep. Clow spoke **in opposition** to **H 290**. He said he is concerned about changing the accreditation and who the authorizers are.

Chris Cargill spoke **in support** of **H 289** and said education choice improves outcomes. He said this bill would allow funds to go to anything that helps students, including special needs students.

Nancy Gregory, Idaho School Board Association, and **Andy Grover**, Idaho Association of School Administrators, and **Paul Stark** testified **in opposition** to **H 289**. They said before more programs are added, there should be more work on a way to free up money to spend on the many other issues at hand.

Committee members spoke about School Vouchers and Education Savings Accounts. They spoke about student testing, accountability and the possibility of private schools raising tuition.

MOTION: Rep. Mendive made a motion to send H 289 to the floor with a DO PASS

recommendation.

S 1100aa: Rep. Hill presented S 1100aa, legislation which would add to existing law to

establish privacy and safety standards in public schools. He said students deserve to feel safe and secure, and school districts are begging for guidance. He said this bill is a fair accommodation and policy for schools and will help students and

teachers feel safe.

Blaine Conzatti, President, Idaho Family Policy Center, spoke about the legal landscape of the school bathroom policy and said sexual discrimination policy allows for separate bathrooms and living facilities. He spoke about federal funding and the constitution. He said schools are for teaching students, not to fight cultural wars.

Kristi Hardy, Sandy Cardon, Cynthia Tria and Amy Henry spoke in support of S 1100aa. They spoke about uncomfortable experiences students have had while using the restroom. They said many children won't drink anything at school because they are afraid to use the restroom and everyone deserves to feel safe at school.

Nicole Trakel, Steven Keyser, and Christian Welp spoke **in support** of **S 1100aa**. They spoke about students who are uncomfortable using locker rooms as it is and this bill would make them even more uncomfortable. They said students thrive when they are comfortable and the majority of students should not be made to feel uncomfortable in order to accommodate a very small few.

Senator Trakel, testified **in support of S 1100aa** and said the republican party platform refuses to accept anything that might confuse bio-gender. He said by trying to make trans-gender students feel comfortable, all the other students feel uncomfortable.

Amy Dundon, ACLU of Idaho, spoke **in opposition** to **S 1100aa.** She spoke about sex and trans-gender based discrimination and hypothesized harm. She said trans-gender students have never caused harm to other students and they should not be discriminated against.

Committee members spoke about policy already in place to allow coaches of the opposite sex to enter locker rooms after mandatory permission. They said student safety is the priority, regardless of gender. They spoke about restitution if schools do not follow procedure and protection for schools who do.

MOTION: Rep. Mendive made a motion to send S 1100aa to the floor with a DO PASS

recommendation.

SUBSTITUTE

Rep. Berch made a substitute motion to send S 1100aa to General Orders. Motion

failed by voice vote.

They spoke about calendar challenges and said this bill would alleviate miscommunication between county clerks and school districts.

H 313: Rep. Furniss presented H 313, legislation which would require feminine hygiene

products to be provided in female and unisex restrooms for grades 6-12. He said the suggestions from the committee have made this a better bill. He said local school boards can choose what products and what vendors to use. He spoke about

the cost to put dispensers in the school restrooms.

In response to questions, Rep. Furniss said there currently is not a policy for

feminine hygiene products in schools.

Vice Chair McCann spoke in support of H 313 and said this bill is about hygiene and respecting girls. She said other hygiene products are provided by the schools,

specifically toilet paper, paper towels, and soap.

Avery Hendrix, Brooke Nelson, and April Morrison testified in support of H 313. They spoke about students who are too embarrassed to ask adults for feminine hygiene products, and would rather miss classes to go home for supplies. They

spoke about poor hygiene which could lead to infections.

Dr. Kristine Bowlden, Ruth Schneider, Kyle Ellefson and Jennifer Lingle testified **in support** of **H 313** and spoke about the physical effects of menstruation. They spoke about the experiences of students who had to ask adults for feminine hygiene products and said it would be a common courtesy to provide the products.

Susan Thompson, Madeline Patterson, and Doneta Stephesen testified in support of H 313 and said periods cannot be regulated. They spoke about girls who unexpectedly start a period at school, student privacy, family poverty and how providing something so basic can help students stay engaged in classroom studies and school functions.

Alison Russel and Dominic Sparling testified in support of H 313. They said being a teenager is hard and menstrual health adds to this difficulty. They spoke about using a restroom to find there is no toilet paper and said they feel sorry for girls who do not have feminine products.

Carol Mitchell and Cindy Thorngren testified in support of H 313 and spoke about panic, embarrassment, privacy and bullying. They said they support women

and girls.

MOTION: Rep. Galaviz made a motion to send H 313 to the floor with a DO PASS

recommendation.

Reps. Galaviz, Berch and Lanting spoke in support of H 313. They spoke about providing assistance to families who cannot afford feminine hygiene products, teachers who pay for products out of their own pockets and the shortage of nurses in schools today. They spoke about frustrations when restrooms run out of toilet paper or paper towels and they think feminine hygiene products should be made available.

Reps. Hawkins, Clow, Wisniewski, and Price spoke in opposition to H 313 and said feminine hygiene products should be purchased using individual school budgets. They spoke about the cost of dispensers, possible vandalism and mandating schools to provide products. They said this should be taken care of at a local level.

Reps. McCann, Yamamoto, and Woodings spoke **in support** of **H 313**. They spoke about state wide policy, clarity and consistency. They said school discretionary funds are already spent.

Committee members spoke about biological boys and biological girls and said female hygiene products would not be allowed in male restrooms.

Other committee members said some students do not have parental engagement and need government support in schools.

VOTE ON THE MOTION:

Chair Yamamoto called for a vote on the motion to send H 313 to the floor with a DO PASS recommendation. Motion carried by voice vote. Reps. Wisniewski, Hawkins, and Price requested to be recorded as voting NAY. Rep. Furniss will sponsor the bill on the floor.

Chair Yamamoto passed the gavel to Vice Chair McCann.

S 1015:

Rep. Lanting presented **S 1015**, legislation which would amend existing law to limit applicability to full-time students. He said this would allow school districts to have more flexibility when determining a full-time student. **Tracie Bent**, Chief Planning and Policy Officer, State Board of Education, spoke about adding the term to both sections of code for proper reporting. She spoke about extended learning opportunities and eligibility.

Vice Chair McCann returned the gavel to Chair Yamamoto.

Reps. Ehardt and Nelsen spoke **in support** of **S 1015**. They spoke about school choice, flexibility and activities led by parents.

MOTION:

Rep. Nelsen made a motion to send **S 1015** to the floor with a **DO PASS** recommendation. **Motion carried by voice vote. Rep. Lanting** will sponsor the bill on the floor.

S 1069:

Senator Ward-Engelking presented **S 1069**, legislation which would amend existing law to allow for teacher apprenticeships. She spoke about paraprofessionals in the classroom, teacher shortages and a program to earn credits toward teacher certification.

Senator Semmelroth spoke about registered apprenticeships for K-12 teaching and said student teaching would change from one semester to 3 years.

Committee members said the paid apprenticeship program would provide much needed help in the classroom and properly train up-coming teachers. They spoke about mentors and said the State Board of Education and Higher Education would determine the mentors. They spoke about teachers of record and a standard teaching certificate.

MOTION:

Rep. Mendive made a motion to send **S 1069** to the floor with a **DO PASS** recommendation. **Motion carried by voice vote. Rep. McCann** will sponsor the bill on the floor.

Chair Yamamoto called the meeting to order at 8:00 am.

Cally Roach, Idaho State Board of Education Member, spoke about the various certificates and degrees earned by students, and about Idaho institutions and the differing ways to reach students. She then introduced the presenters.

Maygen Allison, Heavy Duty Truck Student, College of Western Idaho (CWI), spoke about the opportunities which helped her succeed.

Seferino Tapia, CWI Law Enforcement Graduate, spoke about his experiences going through the law enforcement program and all of the hands-on training he received. He remarked he now has a great network of officers available to him in his career as a law enforcement officer.

Marcos Serratos-Garcia, Heavy Duty Truck Instructor, CWI, spoke about his experience of going through the heavy duty truck program and graduating and going to work in the industry, then five years later, CWI invited him back to be an instructor.

Chance Reynolds, Idaho State University (ISU) Secondary Education student, spoke about his positive experience attending ISU and his involvement with the student body government. He commented, with his education degree he would like to return to his hometown to teach.

Jorge Hernandez, Advisory, Boise State University (BSU), spoke about what the state is doing for veterans when they come home and try to transition from military to civilian life. He remarked, at BSU, they provide the necessary support to make veteran students successful.

Keith Exner, current student at BSU, spoke about his studies in medicine after transitioning out of the Navy. He remarked about how much BSU supports veteran students.

S 1070:

Rep. McCann, presented **S 1070**, legislation which would amend Career Technical Centers (CTC) funding. She explained, to be eligible for this funding, at least 15% of the students attending a CTC must come from separate high schools, but rural school districts expressed difficulty in being able to recruit 15% during their start-up years, so this legislation will allow a new CTC to be eligible with an initial enrollment of 5% of the students from separate high schools. After the first year, it would increase by 5% until they reach the 15% requirement. Additionally, she explained, existing programs would be allowed to use a three-year rolling average to calculate the 15% requirement. Finally, this legislation also addresses transportation challenges in rural areas where students may have to travel for an hour each way to participate in career technical education programs in neighboring districts and which high school counts them in regard to the 15% requirement.

In response to committee questions regarding the differences between a school and CTC, and why a CTC gets more funding, **Rep. McCann** replied, CTSs are able to qualify for additional funding because CTC's provide more regional coverage, while schools are more limited. **Rep. McCann** then yielded the podium to **Mike Keckler**.

Mike Keckler, Communication and Legislative Affairs, Idaho State Board of Education, further explained the differences between schools with career technical education programs and CTC's by stating CTC's are focused entirely on career technical education programs, while schools are regular high schools that offer career technical classes. Because CTC's require specialized equipment for classes, they qualify for the additional funding.

In response to a committee question regarding academic studies in CTC's, **Mr. Keckler** replied students would have to attend academic classes in traditional high schools because CTC's only offer technical education courses.

MOTION:

Rep. Berch made a motion to send **S 1070** to the floor with a **DO PASS** recommendation. **Motion carried by voice vote. Rep. McCann** will sponsor the bill on the floor.

H 339:

Rep. McCann, presented **H 339**, legislation which would allow Idaho voters the opportunity to indicate their support or opposition to the question: Should the state of Idaho, the Idaho Legislature, or any state agency direct or appropriate public tax dollars to private K-12 schools, including private religious schools, and for-profit schools? She believes it is important to hear what the citizens of Idaho really want. The advisory question would be added to the November 2024 statewide general election, and the Legislative Council will oversee the crafting of the summary for the advisory question, covering both sides; pro and con.

Speaking **in support** of **H 339**, **Kayla Dodson**, representing herself and **Mary Ruckh**, representing herself, commented it is important to get this clear and simple question out to the general public in order to hear where the citizens of Idaho really want their tax dollars going.

Chris Cargill, representing Mountain States Policy Center, stated they are **in opposition** to **H 339** because the question is misleading, confusing, and will do more harm than good.

Committee members held a discussion on the bill and several expressed concerns over the phrase "for profit" and if that would be too misleading, why are charter schools missing from the advisory question, and whether or not the wording in the question is really clear enough and not misleading.

MOTION:

Rep. Garner made a motion to send **H 339** to the floor with a **DO PASS** recommendation.

Discussion on the motion was held. Committee members expressed similar concerns as previously discussed prior to the motion. Other comments from committee members included, public tax dollars shouldn't go towards private religious schools, there's plenty of time until the November 2024 election to properly educate the public on the issues surrounding the question, and it would be beneficial to see how voters would answer the question.

VOTE ON MOTION:

Chair Yamamoto called for a vote on the motion to send H 339 to the floor with a DO PASS recommendation. Motion carried by voice vote. Reps. Clow, Mendive, Ehardt, Wisniewski, Hawkins, and Price all requested to be recorded as voting NAY. Rep. McCann will sponsor the bill on the floor.

MOTION: Rep. Galaviz made a motion to approve the minutes of March 7, 8, 9, and 13,

2023. Motion carried by voice vote.

Chair Yamamoto introduced Idaho's 2023 Teacher of the Year, **Karen Lauritzen**.

She spoke about the process and honor to receive this award.

Karen Lauritzen, Idaho's 2023 teacher of the year, spoke about her experience teaching K-4 students in different states. She shared her thoughts about ways to improve educator retention in Idaho. Ms. Lauritzen considers turnover, low pay, supplemental levy failure, stress, large classroom sizes, and student mental health needs as barriers to educator retention. She spoke about the decrease in student attendance since the pandemic. She shared concerns the professionalism and expertise of the education career are being weakened by apprenticeship. Her suggestions to retain teachers include making their salary comparable to other bachelor or master degrees, and pay for professional development. She would prefer to see funding come from the state level and to lower the class size so educators can make meaningful connections with students. Ms. Lauritzen wants to teach social emotional learning skills including self awareness, self control and interpersonal skills. She would also like to see a pathway for board certified behavior analysts created in Idaho. Currently, educators have to go out of state to become certified. She believes there needs to be increased funding for student counselors. She would also encourage consideration of community school models which families may need. She explained it is difficult for students to learn and educators to teach when attendance is low. She thinks enrollment-based funding instead of student attendance-based funding would help increase attendance. She would encourage the community to communicate with educators directly to learn their needs.

Chair Yamamoto put the committee at ease for five minutes.

Chair Yamamoto resumed the meeting.

In response to committee questions, **Ms. Lauritzen** shared it would be helpful for parents, elected officials, and school superintendents to visit a classroom to see what is actually happening and be more involved. She shared her thoughts on returning to enrollment-based funding. Ms. Lauritzen explained successful teachers need a wealth of background information and must be able to teach multiple grade levels. While teacher certification in Idaho is for K-8, she is concerned having teacher apprentices only train in a single classroom and with a single grade level would not be adequate. Ms. Lauritzen also expressed concerns about adding to the workload of the mentor-teacher in an apprenticeship program. She further recommended the legislature provide whatever it takes to keep kids from being absent. She explained teachers use their own resources in their classrooms. It is just assumed that teachers do this, despite the fact it is not expected from other professions.

Rep. Clow explained about school attendance vs. enrollment and the impact on attendance during the pandemic.
