1 AN ACT
2 RELATING TO THE APPROPRIATION TO THE PUBLIC CHARTER SCHOOL COMMISSION; AP-
3 PROPRIATING MONEYS TO THE PUBLIC CHARTER SCHOOL COMMISSION FOR FISCAL
4 YEAR 2025; LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT PO-
5 SITIONS; PROVIDING FOR ACCOUNTABILITY REPORTS; AND DECLARING AN EMER-
6 GENCY AND PROVIDING AN EFFECTIVE DATE.

7 Be It Enacted by the Legislature of the State of Idaho:

8 SECTION 1. There is hereby appropriated to the Idaho Public Charter
9 School Commission the following amounts to be expended according to the des-
10 ignated expense classes from the listed funds for the period July 1, 2024,
11 through June 30, 2025:

21 SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519,
22 Idaho Code, the Idaho Public Charter School Commission is authorized no more
23 than five (5.00) full-time equivalent positions at any point during the pe-
24 riod July 1, 2024, through June 30, 2025, unless specifically authorized by
25 the Governor. The Joint Finance-Appropriations Committee will be notified
26 promptly of any increased positions so authorized.

27 SECTION 3. ACCOUNTABILITY REPORTS. Funds specifically identified in
28 statute or in an appropriation act as intended for a certain purpose may
29 be used only for that purpose. Funds provided in this act are subject to
30 accountability reports and management reviews in accordance with Section
31 67-702, Idaho Code, provided the Legislative Services Office auditor has
32 sufficient resources to conduct those reports. State agencies that are
33 authorized to contract for outside audits shall submit those reports to the
34 Joint Finance-Appropriations Committee when those reports become avail-
35 able.

1 SECTION 4. An emergency existing therefor, which emergency is hereby
2 declared to exist, this act shall be in full force and effect on and after
3 July 1, 2024.
